I. KEY INDICATORS

- The Manufacture of coke and refined petroleum products industry in Bulgaria was represented by 13 companies at the end of 2014, compared to 10 in the previous year and 13 in 2012.
- The industry's net loss amounted to BGN 521,669,000 in 2014.
- The industry's total revenue was BGN 7,132,460,000 in 2014, down by 14.58% compared to the previous year.
- The combined costs of the companies in the Manufacture of coke and refined petroleum products industry reached BGN 7,670,864,000 in 2014, down by 10.66% year-on-year.
- The industry's total revenue makes up 9.23% to the country's Gross domestic product (GDP) in 2014, compared to 10.97% for 2013 and 11.94% in 2012.
- A total of 2,070 people were employed in the Manufacture of coke and refined petroleum products industry at the end of 2014, compared to 2,204 in 2013 and 2,203 in 2012.
- Most of the companies in the industry are based in Sofia, followed by Ruse and Pleven.

II. INTRODUCTION

In 2014 the companies in the Manufacture of coke and refined petroleum products industry numbered 13.


In 2013 there were a total of 10 companies operating in the industry. In 2012 their number totalled 13.

III. REVENUES


The total revenue in the industry was BGN 7,132,460,000 in 2014, BGN 8,349,455,000 in 2013 and 8,973,493,000 in 2012.



The companies in the Manufacture of coke and refined petroleum products market of Bulgaria earned combined net sales revenues of BGN 6,911,445,000 in 2014.

In annual terms, sales marked a decline of 14.10% compared to 2013. In comparison to 2012 they dropped by 19.46%. In 2013 sales decreased by 6.24% year-on-year.

The Manufacture of coke and refined petroleum products industry total revenue make up 9.23% to the country's GDP in 2014, compared to 10.97% for 2013 and 11.94% in 2012.



In 2014 the Manufacture of coke and refined petroleum products industry contributed to GDP BGN 6,879,515,000 in Gross value added (GVA) accounting for 4.79% of the total for the country's economy.

In the previous year, the industry's GVA amounted BGN 8,227,328,000, accounting for 6.08% of the total for the

country in 2013. In 2012 the GVA of the Manufacture of coke and refined petroleum products was BGN 8,836,205,000, or 6.89% of the GVA for the country's economy.

We expect, based on the trend in the last three years, the total revenue of the Manufacture of coke and refined petroleum products industry to change at a compound annual growth rate (CAGR) of -10.85% in 2015.

The top 10 companies in terms of total revenue in Manufacture of coke and refined petroleum products accounted for 100.00% of the industry's total in 2014, 100.00% in 2013 and 99.90% in 2012.

The total revenues of the top 10 companies in the Manufacture of coke and refined petroleum products were 9.23% of GDP in 2014, compared to 10.97% for 2013 and 11.93% in 2012.

The top 10 by assets in the Manufacture of coke and refined petroleum products market made up BGN 6,911,344,000, or 100.00% of the total net sales revenue.



The 10 largest companies in terms of total revenue in sector Manufacture of coke and refined petroleum products earned total revenue of BGN 7,132,341,000 and accounted for 100.00% of the industry's total revenue.

IV. EXPENSES

The combined costs of the companies in the Manufacture of coke and refined petroleum products industry reached BGN 7,670,864,000 in 2014.




In annual terms, total expenses dropped by 10.66% compared to 2013 and decreased by 15.39% in comparison to 2012.

The total operating expenses of the companies in the Manufacture of coke and refined petroleum products industry were BGN 7,502,703,000 in 2014.

Operating costs went down by 10.52% compared with the previous year and decreased by 14.73% when compared to 2012.

We expect, based on the trend in the last three years, the total costs of the Manufacture of coke and refined petroleum products industry to change at a compound annual growth rate (CAGR) of -8.02% in 2015.

Employment expenses in the Manufacture of coke and refined petroleum products industry dropped by 0.01% on the year to BGN 77,703,000 in 2014.




The monthly costs per employee in the Manufacture of coke and refined petroleum products industry averaged BGN 3,128 in 2014, BGN 2,938 in 2013 and BGN 2,941 in 2012.

The monthly social security costs per employee in the industry averaged BGN 432 in 2014, versus BGN 408 in 2013 and BGN 420 in 2012.



The industry's tax revenue stood at BGN 16,735,000 in 2014. In 2013 it received tax revenue of BGN 10,763,000. In 2012 the industry collected BGN 4,917,000 in tax revenue.



V. PROFITABILITY

The industry's net loss amounted to BGN 521,669,000 in 2014, compared to a net loss of BGN 225,665,000 in 2013 and a net loss of BGN 88,003,000 in 2012.



The combined operating losses of the companies in the Manufacture of coke and refined petroleum products field decreased by 123.26% y/y to BGN 538,410,000 in 2014.

The profit margin for the Manufacture of coke and refined petroleum products industry stood at -7.67% in 2014, while in 2013 it amounted to -2.95% and -1.06% in 2012.

The Manufacture of coke and refined petroleum products industry's return on equity (ROE) is -123.97% compared to -75.92% in 2013 and -16.89% in 2012.

The Manufacture of coke and refined petroleum products's return on assets (ROA) was -10.59%, while in 2013 it amounted to -4.74% and -2.28% in 2012.

The average net sales revenue per employee in the Manufacture of coke and refined petroleum products industry amounted to BGN 3,338,862 in 2014, down by 8.54% compared to 2013 and down by 14.28% compared to 2012.

The industry's average operating revenue per employee fell by 8.44% year-on-year in 2014 to BGN 3,393,273. It dropped by 14.81% compared to 2012.

The Manufacture of coke and refined petroleum products field generated an average BGN 3,445,633 in total revenue per employee. In 2013 and 2012 the figure was BGN 3,788,319 and BGN 4,073,306, respectively.

The average total revenue per company in the Manufacture of coke and refined petroleum products industry went down to BGN 548,650,769 in 2014 from BGN 834,945,500 in 2013. The 2012 value was BGN 690,268,692.

A company in the Manufacture of coke and refined petroleum products industry made on average a net sales revenue of BGN 531,649,615 in 2014, compared to BGN 804,555,100 in 2013 and BGN 660,099,538 in 2012.

The Manufacture of coke and refined petroleum products industry made 2.97% of the overall sales country-wide, reducing its market share by 0.67 pp.

Operating profit per employee for the industry as a whole was BGN -260,101 in 2014. For comparison in 2013 it amounted to BGN -109,417 and BGN -109,417 in 2012.

The total indebtedness of the companies in the Manufacture of coke and refined petroleum products industry was BGN 4,475,385,000 versus BGN 4,428,774,000 a year ago. In 2012 the industry's indebtedness totalled BGN 3,301,846,000.

Debt-to-assets ratio of the companies in the industry is 0.91 in 2014. It was 0.93 in 2013 and 0.86 in 2012.


According to market experts, the greatest impact on the development of the Manufacture of coke and refined petroleum products industry has expenses for raw materials and external services. In 2014 it stood at BGN 6,922,284,000, according to the financial statements of the companies in the industry. In 2013 the figure was BGN 8,035,783,000 and BGN 8,432,456,000 in 2012.

VI. EMPLOYMENT

A total of 2,070 people were employed in the Manufacture of coke and refined petroleum products industry at the end of 2014, compared to 2,204 in 2013 and 2,203 in 2012.

When it comes to employees the sizes of firms vary. Some 4 have less than 50 employees, 5 fall in the 50 to 250 range, 1 count more than 250 employees *.

employees with the largest employer being Retail trade, except of motor vehicles and motorcycles with 204,297 and Libraries, archives, museums and other cultural activities at the bottom with 66 employees.

The Manufacture of coke and refined petroleum products's share in the country's total employment was 0.09% in 2014, 0.10% in 2013 and 0.12% in 2012.

We expect, based on the trend in the last three years, the number of employees of the Manufacture of coke and refined petroleum products industry to change at a compound annual growth rate (CAGR) of -3.07% in 2015.
