# I. KEY INDICATORS

- The Manufacture of tobacco products industry in Bulgaria was represented by 19 companies at the end of 2014, compared to 18 in the previous year and 18 in 2012.
- The industry's net profit amounted to BGN 38,505,000 in 2014.
- The industry's total revenue was BGN 919,713,000 in 2014, up by 7.59% compared to the previous year.
- The combined costs of the companies in the Manufacture of tobacco products industry reached BGN 876,317,000 in 2014, up by 9.62% year-on-year.
- The industry's total revenue makes up 1.19% to the country's Gross domestic product (GDP) in 2014, compared to 1.12% for 2013 and 1.07% in 2012.
- A total of 3,140 people were employed in the Manufacture of tobacco products industry at the end of 2014, compared to 3,363 in 2013 and 1,928 in 2012.
- Most of the companies in the industry are based in Sofia, followed by Parvomay and Plovdiv.

## **II. INTRODUCTION**

In 2014 the companies in the Manufacture of tobacco products industry numbered 19.

In 2013 there were a total of 18 companies operating in the industry. In 2012 their number totalled 18.

# **III. REVENUES**


The total revenue in the industry was BGN 919,713,000 in 2014, BGN 854,841,000 in 2013 and 805,977,000 in 2012.

The companies in the Manufacture of tobacco products market of Bulgaria earned combined net sales revenues of BGN 804,087,000 in 2014.

In annual terms, sales marked an increase of 0.14% compared to 2013. In comparison to 2012 they went up by 11.31%. In 2013 sales grew by 11.16% year-on-year.

The Manufacture of tobacco products industry total revenue make up 1.19% to the country's GDP in 2014, compared to 1.12% for 2013 and 1.07% in 2012.



In 2014 the Manufacture of tobacco products industry contributed to GDP BGN 872,744,000 in Gross value added (GVA) accounting for 0.61% of the total for the country's economy.

In the previous year, the industry's GVA amounted BGN 815,283,000, accounting for 0.60% of the total for the

country in 2013. In 2012 the GVA of the Manufacture of tobacco products was BGN 758,896,000, or 0.59% of the GVA for the country's economy.

We expect, based on the trend in the last three years, the total revenue of the Manufacture of tobacco products industry to change at a compound annual growth rate (CAGR) of 6.82% in 2015.

The top 10 companies in terms of total revenue in Manufacture of tobacco products accounted for 99.47% of the industry's total in 2014, 99.58% in 2013 and 99.59% in 2012.

The total revenues of the top 10 companies in the Manufacture of tobacco products were 1.18% of GDP in 2014, compared to 1.12% for 2013 and 1.07% in 2012.

The top 10 by assets in the Manufacture of tobacco products field made up BGN 800,290,000, or 99.53% of the total net sales revenue.



The 10 largest companies in terms of total revenue in sector Manufacture of tobacco products earned total revenue of BGN 914,837,000 and accounted for 99.47% of the industry's total revenue.

# **IV. EXPENSES**

The combined costs of the companies in the Manufacture of tobacco products industry reached BGN 876,317,000 in 2014.




In annual terms, total expenses went up by 9.62% compared to 2013 and increased by 25.54% in comparison to 2012.

The total operating expenses of the companies in the Manufacture of tobacco products industry were BGN 840,360,000 in 2014.

Operating costs went up by 7.48% compared with the previous year and increased by 23.90% when compared to 2012.

We expect, based on the trend in the last three years, the total costs of the Manufacture of tobacco products industry to change at a compound annual growth rate (CAGR) of 12.05% in 2015.

Employment expenses in the Manufacture of tobacco products industry decreased by 0.48% on the year to BGN 74,958,000 in 2014.




The monthly costs per employee in the Manufacture of tobacco products industry averaged BGN 1,989 in 2014, BGN 1,866 in 2013 and BGN 3,353 in 2012.

The monthly social security costs per employee in the industry averaged BGN 256 in 2014, versus BGN 224 in 2013 and BGN 678 in 2012.



The industry's tax expenses stood at BGN 4,891,000 in 2014. In 2013 it paid taxes of BGN 6,012,000. In 2012 the industry paid BGN 10,718,000 in taxes.



# V. PROFITABILITY

The industry's net profit amounted to BGN 38,505,000 in 2014, compared to a net profit of BGN 49,389,000 in 2013 and a net profit of BGN 97,226,000 in 2012.



The combined operating earnings of the companies in the Manufacture of tobacco products market went down by 21.82% y/y to BGN 43,417,000 in 2014.

The profit margin for the Manufacture of tobacco products industry stood at 4.83% in 2014, while in 2013 it amounted to 6.57% and 13.62% in 2012.

The Manufacture of tobacco products industry's return on equity (ROE) is 8.14% compared to 11.26% in 2013 and 21.31% in 2012.

The Manufacture of tobacco products's return on assets (ROA) was 3.14%, while in 2013 it amounted to 4.56% and 10.22% in 2012.

About 10.00% of the 10 leading companies in terms of net profit per employee are located in SANDANSKI, while 10.00% are RADINOVO-based and 10.00% are headquartered in BLAGOEVGRAD.

The average net sales revenue per employee in the Manufacture of tobacco products industry amounted to BGN 256,079 in 2014, up by 7.25% compared to 2013 and down by 31.65% compared to 2012.

The industry's average operating revenue per employee rose by 13.90% year-on-year in 2014 to BGN 286,459. It dropped by 30.32% compared to 2012.

The Manufacture of tobacco products sector generated an average BGN 292,902 in total revenue per employee. In 2013 and 2012 the figure was BGN 254,190 and BGN 418,038, respectively.

The average total revenue per company in the Manufacture of tobacco products industry went up to BGN 48,405,947 in 2014 from BGN 47,491,167 in 2013. The 2012 value was BGN 44,776,500.

A company in the Manufacture of tobacco products sector made on average a net sales revenue of BGN 42,320,368 in 2014, compared to BGN 44,611,056 in 2013 and BGN 40,132,611 in 2012.

The Manufacture of tobacco products industry made 0.35% of the overall sales country-wide, decreasing its market share by 0.02 pp.

Operating profit per employee for the industry as a whole was BGN 13,827 in 2014. For comparison in 2013 it amounted to BGN 16,514 and BGN 16,514 in 2012.

The total indebtedness of the companies in the Manufacture of tobacco products industry was BGN 740,423,000 versus BGN 632,538,000 a year ago. In 2012 the industry's indebtedness totalled BGN 481,926,000.

Debt-to-assets ratio of the companies in the industry is 0.60 in 2014. It was 0.58 in 2013 and 0.51 in 2012.


According to market experts, the greatest impact on the development of the Manufacture of tobacco products industry has net sales revenue to production and land plots ratio. In 2014 it stood at 84, according to the financial statements of the companies in the industry. In 2013 the figure was 132 and 200 in 2012.

# **VI. EMPLOYMENT**

A total of 3,140 people were employed in the Manufacture of tobacco products market at the end of 2014, compared to 3,363 in 2013 and 1,928 in 2012.

When it comes to employees the sizes of firms vary. Some 9 have less than 50 employees, 4 fall in the 50 to 250 range, 5 count more than 250 employees \*.

\* Companies without data in the number of employees at end of the year are not taken into consideration.



The employees of the leading 10 companies in terms of numbers make up 98.82% of the workforce in the industry in 2014.

The Manufacture of tobacco products industry is the 64th largest employer in the country with 3,140 employees with the largest employer being Retail trade, except of motor vehicles and motorcycles with 204,297 and Libraries, archives, museums and other cultural activities at the bottom with 66 employees.

The Manufacture of tobacco products's share in the country's total employment was 0.14% in 2014, 0.16% in 2013 and 0.11% in 2012.

We expect, based on the trend in the last three years, the number of employees of the Manufacture of tobacco products industry to change at a compound annual growth rate (CAGR) of 27.62% in 2015.
