I. KEY INDICATORS

- The Remediation activities and other waste management services industry in Bulgaria was represented by 71 companies at the end of 2014, compared to 65 in the previous year and 55 in 2012.
- The industry's net profit amounted to BGN 4,397,000 in 2014.
- The industry's total revenue was BGN 135,854,000 in 2014, up by 16.18% compared to the previous year.
- The combined costs of the companies in the Remediation activities and other waste management services industry reached BGN 130,796,000 in 2014, up by 16.04% year-onyear.
- The industry's total revenue makes up 0.18% to the country's Gross domestic product (GDP) in 2014, compared to 0.15% for 2013 and 0.11% in 2012.
- A total of 788 people were employed in the Remediation activities and other waste management services industry at the end of 2014, compared to 742 in 2013 and 663 in 2012.
- Most of the companies in the industry are based in Sofia, followed by Varna and Plovdiv.

II. INTRODUCTION

In 2014 the companies in the Remediation activities and other waste management services industry numbered 71.


In 2013 there were a total of 65 companies operating in the industry. In 2012 their number totalled 55.

III. REVENUES


The total revenue in the industry was BGN 135,854,000 in 2014, BGN 116,934,000 in 2013 and 83,061,000 in 2012.



The companies in the Remediation activities and other waste management services market of Bulgaria earned combined net sales revenues of BGN 124,685,000 in 2014.

In annual terms, sales marked an increase of 21.40% compared to 2013. In comparison to 2012 they increased by 83.92%. In 2013 sales increased by 51.51% year-on-year.

The Remediation activities and other waste management services industry total revenue make up 0.18% to the country's GDP in 2014, compared to 0.15% for 2013 and 0.11% in 2012.



In 2014 the Remediation activities and other waste management services industry contributed to GDP BGN 116,043,000 in Gross value added (GVA) accounting for 0.08% of the total for the country's economy.

In the previous year, the industry's GVA amounted BGN

99,125,000, accounting for 0.07% of the total for the country in 2013. In 2012 the GVA of the Remediation activities and other waste management services was BGN 62,683,000, or 0.05% of the GVA for the country's economy.

We expect, based on the trend in the last three years, the total revenue of the Remediation activities and other waste management services industry to change at a compound annual growth rate (CAGR) of 27.89% in 2015.

The top 10 companies in terms of total revenue in Remediation activities and other waste management services accounted for 90.92% of the industry's total in 2014, 91.81% in 2013 and 91.16% in 2012.

The total revenues of the top 10 companies in the Remediation activities and other waste management services were 0.16% of GDP in 2014, compared to 0.14% for 2013 and 0.10% in 2012.

The top 10 by assets in the Remediation activities and other waste management services market made up BGN 73,874,000, or 59.25% of the total net sales revenue.



The combined costs of the companies in the Remediation activities and other waste management services industry reached BGN 130,796,000 in 2014.



In annual terms, total expenses rose by 16.04% compared to 2013 and increased by 65.86% in comparison to 2012.


The total operating expenses of the companies in the Remediation activities and other waste management services industry were BGN 128,347,000 in 2014.

Operating costs went up by 14.93% compared with the previous year and rose by 65.41% when compared to 2012.

We expect, based on the trend in the last three years, the total costs of the Remediation activities and other waste management services industry to change at a compound annual growth rate (CAGR) of 28.79% in 2015.

SeeNews Industry Report

Employment expenses in the Remediation activities and other waste management services industry grew by 11.98% on the year to BGN 9,989,000 in 2014.



The highest growth in labour costs, of 11.98%, was registered by Remediation activities and other waste management services.


The monthly costs per employee in the Remediation activities and other waste management services industry averaged BGN 1,056 in 2014, BGN 1,002 in 2013 and BGN 969 in 2012.

The monthly social security costs per employee in the industry averaged BGN 156 in 2014, versus BGN 147 in 2013 and BGN 134 in 2012.



The industry's tax expenses stood at BGN 661,000 in 2014. In 2013 it paid taxes of BGN 331,000. In 2012 the industry paid BGN 196,000 in taxes.



V. PROFITABILITY

The industry's net profit amounted to BGN 4,397,000 in 2014, compared to a net profit of BGN 3,886,000 in 2013 and a net profit of BGN 4,007,000 in 2012.



The combined operating earnings of the companies in the Remediation activities and other waste management services sector went up by 28.94% y/y to BGN 5,449,000 in 2014.

The profit margin for the Remediation activities and other waste management services industry stood at 4.02% in 2014, while in 2013 it amounted to 3.69% and 5.26% in 2012.

The Remediation activities and other waste management services industry's return on equity (ROE) is 10.16% compared to 9.90% in 2013 and 10.68% in 2012.

The Remediation activities and other waste management services's return on assets (ROA) was 4.76%, while in 2013 it amounted to 4.53% and 4.92% in 2012.

About 20.00% of the 10 leading companies in terms of net profit per employee are located in SOFIA, while 20.00% are PLOVDIV-based and 10.00% are headquartered in SHUMEN.

The average net sales revenue per employee in the Remediation activities and other waste management services industry amounted to BGN 158,230 in 2014, up by 14.31% compared to 2013 and up by 54.75% compared to 2012.

The industry's average operating revenue per employee grew by 11.39% year-on-year in 2014 to BGN 172,084. It increased by 43.10% compared to 2012.

The Remediation activities and other waste management services market generated an average BGN 172,404 in total revenue per employee. In 2013 and 2012 the figure was BGN 157,593 and BGN 125,281, respectively.

The average total revenue per company in the Remediation activities and other waste management services industry increased to BGN 1,913,437 in 2014 from BGN 1,798,985 in 2013. The 2012 value was BGN 1,510,200.

A company in the Remediation activities and other waste management services field made on average a net sales revenue of BGN 1,756,127 in 2014, compared to BGN 1,580,154 in 2013 and BGN 1,232,600 in 2012.

The Remediation activities and other waste management services industry made 0.05% of the overall sales countrywide, increasing its market share by 0.01 pp.

Operating profit per employee for the industry as a whole was BGN 6,915 in 2014. For comparison in 2013 it amounted to BGN 5,695 and BGN 5,695 in 2012.

The total indebtedness of the companies in the Remediation activities and other waste management services industry was BGN 47,106,000 versus BGN 44,144,000 a year ago. In 2012 the industry's indebtedness totalled BGN 41,386,000.

Debt-to-assets ratio of the companies in the industry is 0.51 in 2014. It was 0.52 in 2013 and 0.51 in 2012.


According to market experts, the greatest impact on the development of the Remediation activities and other waste management services industry has operating profit / loss. In 2014 it stood at BGN 5,449,000, according to the financial statements of the companies in the industry. In 2013 the figure was BGN 4,226,000 and BGN 4,192,000 in 2012.

VI. EMPLOYMENT

A total of 788 people were employed in the Remediation activities and other waste management services sector at the end of 2014, compared to 742 in 2013 and 663 in 2012.

When it comes to employees the sizes of firms vary. Some 36 have less than 50 employees, 4 fall in the 50 to 250 range *.

* Companies without data in the number of employees at end of the year are not taken into consideration.



The employees of the leading 10 companies when it comes to numbers make up 90.48% of the workforce in the industry in 2014.

The Remediation activities and other waste management services industry is the 75th largest employer in the country with 788 employees with the largest employer being Retail trade, except of motor vehicles and motorcycles with 204,297 and Libraries, archives, museums and other cultural activities at the bottom with 66 employees.

The Remediation activities and other waste management services's share in the country's total employment was 0.04% in 2014, 0.03% in 2013 and 0.04% in 2012.

We expect, based on the trend in the last three years, the number of employees of the Remediation activities and other waste management services industry to change at a compound annual growth rate (CAGR) of 9.02% in 2015.
