


I. KEY INDICATORS

- The Air transport industry in Bulgaria was represented by 50 companies at the end of 2017, compared to 49 in the previous year and 46 in 2015.
- The industry's net loss amounted to BGN 24,889,000 in 2017.
- The industry's total revenue was BGN 853,201,000 in 2017, up by 10.16% compared to the previous year.
- The combined costs of the companies in the Air transport industry reached BGN 879,388,000 in 2017, up by 11.57% year-on-year.
- The industry's total revenue makes up 0.89% to the country's Gross domestic product (GDP) in 2017, compared to 0.84% for 2016 and 0.94% in 2015.
- A total of 2,010 people were employed in the Air transport industry in 2017, compared to 2,012 in 2016 and 1,892 in 2015.
- Most of the companies in the industry are based in Sofia, followed by Varna and Plovdiv.

II. INTRODUCTION

In 2017 the companies in the Air transport industry numbered 50, distributed in 2 sectors.






In 2016 there were a total of 49 companies operating in the industry. In 2015 their number totalled 46.

III. REVENUES


The total revenue in the industry was BGN 853,201,000 in 2017, BGN 774,525,000 in 2016 and 843,691,000 in 2015.



The companies in the Air transport market of Bulgaria earned combined net sales revenues of BGN 762,759,000 in 2017.

In annual terms, sales marked an increase of 5.28% compared to 2016. In comparison to 2015 they went up by 1.41%. In 2016 sales increased by 3.67% year-on-year.

The Air transport industry total revenue make up 0.89% to the country's GDP in 2017, compared to 0.84% for 2016 and 0.94% in 2015.



In 2017 the Air transport industry contributed to GDP BGN 704,274,000 in Gross value added (GVA) accounting for 0.41% of the total for the country's economy.

In the previous year, the industry's GVA amounted BGN 717,306,000, accounting for 0.47% of the total for the country in 2016. In 2015 the GVA of the Air transport was BGN 772,662,000, or 0.50% of the GVA for the country's economy.



We expect, based on the trend in the last three years, the total revenue of the Air transport industry to change at a compound annual growth rate (CAGR) of 0.56% in 2018.

Passenger air transport contributed net sales revenue of BGN 663,292,000 or 86.96% of the total net sales in the industry, and sector Freight air transport - BGN 99,467,000 (13.04%).





The highest growth, of 13.50%, was recorded by Freight air transport. There was no industry's sector to report a drop in net sales revenues.



The 10 largest companies in terms of total revenue in sector Freight air transport earned total revenue of BGN 109,698,000 and accounted for 12.86% of the industry's total revenue.

IV. EXPENSES

The combined costs of the companies in the Air transport industry reached BGN 879,388,000 in 2017.




In annual terms, total expenses went up by 11.57% compared to 2016 and grew by 5.50% in comparison to 2015.

The total operating expenses of the companies in the Air transport industry were BGN 835,112,000 in 2017.

Operating costs grew by 11.22% compared with the previous year and went up by 7.66% when compared to 2015.

We expect, based on the trend in the last three years, the total costs of the Air transport industry to change at a compound annual growth rate (CAGR) of 2.71% in 2018.

Passenger air transport reported the highest total costs, of BGN 778,148,000, followed by Freight air transport with BGN 101,240,000.




Freight air transport marked the highest annual rise in total expenses, of 16.17%.

In terms of operating expenses, the highest rise, of 14.88%, was recorded by the Freight air transport sector.

The biggest spenders in the industry, with costs of over 10% of industry's costs, numbered 5, including AVIOSTART OOD, CARGO AIR OOD, BULGARIA AIR AD, B H AIR OOD, BULGARIAN AIR CHARTER EAD. The medium spenders, or those in the 5% and 10% range count 3 and include BUL AIR EOOD, WIZZ AIR HUNGARY BRANCH BULGARIA, HELI AIR SERVICES AD. Below 5% threshhold are 42 companies, including HOSPIS - TONCHEVA OOD, D I D KARGO OOD, VALAVIO EOOD, INTERSKY AD, OLIMPIK EAR - KLON BULGARIA.

Employment expenses in the Air transport industry increased by 8.00% on the year to BGN 85,366,000 in 2017.



The highest growth in labour costs, of 9.86%, was registered by Passenger air transport, while Freight air transport marked the sharpest fall, of 2.46%.

The monthly costs per employee in the Air transport industry averaged BGN 3,539 in 2017, BGN 3,274 in 2016 and BGN 3,007 in 2015.

The monthly social security costs per employee in the industry averaged BGN 458 in 2017, versus BGN 446 in 2016 and BGN 426 in 2015.





V. PROFITABILITY

The industry's net loss amounted to BGN 24,889,000 in 2017, compared to a net loss of BGN 17,267,000 in 2016 and a net profit of BGN 6,708,000 in 2015.


The profit margin for the Air transport industry stood at -3.18% in 2017, while in 2016 it amounted to -1.82% and 1.26% in 2015.





The Air transport industry's return on equity (ROE) is -11.19% compared to -11.42% in 2016 and 3.56% in 2015.

The Air transport's return on assets (ROA) was -3.58%, while in 2016 it amounted to -2.39% and 1.05% in 2015.

About 100.00% of the 10 leading companies in terms of net profit per employee are located in SOFIA.

The average net sales revenue per employee in the Air transport industry amounted to BGN 379,482 in 2017, up by 5.38% compared to 2016 and down by 4.54% compared to 2015.

The industry's average operating revenue per employee grew by 9.85% year-on-year in 2017 to BGN 409,811. It decreased by 3.02% compared to 2015.

The Air transport market generated an average BGN 424,478 in total revenue per employee. In 2016 and 2015 the figure was BGN 384,953 and BGN 445,925, respectively.

The average total revenue per company in the Air transport industry increased to BGN 17,064,020 in 2017 from BGN 15,806,633 in 2016. The 2015 value was BGN 18,341,109.

A company in the Air transport field made on average a net sales revenue of BGN 15,255,180 in 2017, compared to BGN 14,786,490 in 2016 and BGN 16,350,652 in 2015.

The Air transport industry made 0.28% of the overall sales country-wide, reducing its market share by 0.01 pp.

Operating profit per employee for the industry as a whole was BGN -13,028 in 2017. For comparison in 2016 it amounted to BGN -6,797 and BGN -6,797 in 2015.

The total indebtedness of the companies in the Air transport industry was BGN 466,038,000 versus BGN 564,891,000 a year ago. In 2015 the industry's indebtedness totalled BGN 446,161,000.

Debt-to-assets ratio of the companies in the industry is 0.67 in 2017. It was 0.78 in 2016 and 0.70 in 2015.

According to market experts, the greatest impact on the development of the Air transport industry has net sales revenue from services. In 2017 it stood at BGN 692,253,000, according to the financial statements of the companies in the industry. In 2016 the figure was BGN 719,267,000 and BGN 746,753,000 in 2015.



NUMBER OF EMPLOYEES BY INDUSTRY SECTORS



The Air transport's share in the country's total employment was 0.09% in 2017, 0.10% in 2016 and 0.10% in 2015.
