
I. KEY INDICATORS

- The Extraction of crude petroleum and natural gas industry in Bulgaria was represented by 6 companies at the end of 2017, compared to 6 in the previous year and 8 in 2015.
- The industry's net profit amounted to BGN 37,132,000 in 2017.
- The industry's total revenue was BGN 90,259,000 in 2017, up by 14.60% compared to the previous year.
- The combined costs of the companies in the Extraction of crude petroleum and natural gas industry reached BGN 52,382,000 in 2017, down by 45.90% year-on-year.
- The industry's total revenue makes up 0.09% to the country's Gross domestic product (GDP) in 2017, compared to 0.08% for 2016 and 0.09% in 2015.
- A total of 27 people were employed in the Extraction of crude petroleum and natural gas industry in 2017, compared to 532 in 2016 and 610 in 2015.
- Most of the companies in the industry are based in Sofia, followed by Varna.

II. INTRODUCTION

In 2017 the companies in the Extraction of crude petroleum and natural gas industry numbered 6, distributed in 2 sectors.






In 2016 there were a total of 6 companies operating in the industry. In 2015 their number totalled 8.

III. REVENUES

The total revenue in the industry was BGN 90,259,000 in 2017, BGN 78,762,000 in 2016 and 83,811,000 in 2015.




The companies in the Extraction of crude petroleum and natural gas market of Bulgaria earned combined net sales revenues of BGN 22,058,000 in 2017.

In annual terms, sales marked a decline of 62.89% compared to 2016. In comparison to 2015 they fell by 62.94%. In 2016 sales decreased by 0.14% year-on-year.

The Extraction of crude petroleum and natural gas industry total revenue make up 0.09% to the country's GDP in 2017, compared to 0.08% for 2016 and 0.09% in 2015.

SeeNews Industry Report



In 2017 the Extraction of crude petroleum and natural gas industry contributed to GDP BGN 76,699,000 in Gross value added (GVA) accounting for 0.05% of the total for the country's economy.

In the previous year, the industry's GVA amounted BGN 67,194,000, accounting for 0.04% of the total for the country in 2016. In 2015 the GVA of the Extraction of crude petroleum and natural gas was BGN 70,178,000, or 0.05% of the GVA for the country's economy.

We expect, based on the trend in the last three years, the total revenue of the Extraction of crude petroleum and natural gas industry to change at a compound annual growth rate (CAGR) of 3.78% in 2018.

Extraction of natural gas contributed net sales revenue of BGN 22,058,000 or 100.00% of the total net sales in the industry.

There was no industry's sector to report a growth in net sales revenues. In terms of annual drop, the top position was occupied by Extraction of natural gas with 62.89%.



IV. EXPENSES

The combined costs of the companies in the Extraction of crude petroleum and natural gas industry reached BGN 52,382,000 in 2017.




In annual terms, total expenses fell by 45.90% compared to 2016 and went down by 16.45% in comparison to 2015.

The total operating expenses of the companies in the Extraction of crude petroleum and natural gas industry were BGN 36,881,000 in 2017.

Operating costs went down by 60.28% compared with the previous year and went down by 36.85% when compared to 2015.

We expect, based on the trend in the last three years, the total costs of the Extraction of crude petroleum and natural gas industry to change at a compound annual growth rate (CAGR) of -8.60% in 2018.

Extraction of natural gas reported the highest total costs, of BGN 33,024,000, followed by Extraction of crude petroleum with BGN 19,358,000.




There was no industry's sector to report a rise in total costs. In terms of annual fall, the top position was occupied by Extraction of crude petroleum with 47.95%.

There was no industry's sector to report a rise in operating costs. In terms of annual fall, the top position was occupied by Extraction of natural gas with 68.72%.

The biggest spenders in the industry, with costs of over 10% of industry's costs, numbered 3, including PETROCELTIC SARL LUXEMBOURG BRANCH, SHEL EKSPLOREYSHAN END PRADAKSHAN (59) B.V. – KLON BULGARIA, PETROCELTIC BULGARIA EOOD. Below 5% threshhold are 3 companies, including MIZIYA OPEREYSHANS (BULGARIA) OOD, MIZIYA OYL END GAZ (BULGARIA) EOOD, SHEL INTERNESHANAL EKSPLOREYSHAN END DIVELAPMANT ITALIYA S.P.A. – KLON BULGARIA KCHT.

Employment expenses in the Extraction of crude petroleum and natural gas industry dropped by 85.34% on the year to BGN 1,111,000 in 2017.



The monthly costs per employee in the Extraction of crude petroleum and natural gas industry averaged BGN 3,429 in 2017, BGN 1,187 in 2016 and BGN 1,269 in 2015.

The monthly social security costs per employee in the industry averaged BGN 377 in 2017, versus BGN 156 in 2016 and BGN 151 in 2015.











The Extraction of crude petroleum and natural gas industry's return on equity (ROE) is 18.32% compared to -8.08% in 2016 and 7.23% in 2015.

The Extraction of crude petroleum and natural gas's return on assets (ROA) was 10.51%, while in 2016 it amounted to -4.90% and 5.16% in 2015.

The average net sales revenue per employee in the Extraction of crude petroleum and natural gas industry amounted to BGN 816,963 in 2017, up by 631.30% compared to 2016 and up by 737.31% compared to 2015.

The industry's average operating revenue per employee grew by 2106.52% year-on-year in 2017 to BGN 2,835,963. It went up by 2474.39% compared to 2015.

The Extraction of crude petroleum and natural gas sector generated an average BGN 3,342,926 in total revenue per employee. In 2016 and 2015 the figure was BGN 148,049 and BGN 137,395, respectively.

The average total revenue per company in the Extraction of crude petroleum and natural gas industry grew to BGN 15,043,167 in 2017 from BGN 13,127,000 in 2016. The 2015 value was BGN 10,476,375.

A company in the Extraction of crude petroleum and natural gas sector made on average a net sales revenue of BGN 3,676,333 in 2017, compared to BGN 9,905,333 in 2016 and BGN 7,439,750 in 2015.

The Extraction of crude petroleum and natural gas industry made 0.01% of the overall sales country-wide, reducing its market share by 0.02 pp.

Operating profit per employee for the industry as a whole was BGN 1,402,852 in 2017. For comparison in 2016 it amounted to BGN -33,966 and BGN -33,966 in 2015.

The total indebtedness of the companies in the Extraction of crude petroleum and natural gas industry was BGN 134,207,000 versus BGN 135,859,000 a year ago. In 2015 the industry's indebtedness totalled BGN 86,028,000.

Debt-to-assets ratio of the companies in the industry is 0.38 in 2017. It was 0.34 in 2016 and 0.23 in 2015.

According to market experts, the greatest impact on the development of the Extraction of crude petroleum and natural gas industry has change in inventories of finished goods and work in progress. In 2017 it stood at BGN 0, according to the financial statements of the companies in the industry. In 2016 the figure was BGN 662,000 and BGN 234,000 in 2015.


VI. EMPLOYMENT
