


I. KEY INDICATORS

- The Manufacture of basic metals industry in Bulgaria was represented by 199 companies at the end of 2015, compared to 198 in the previous year and 192 in 2013.
- The industry's net profit amounted to BGN 107,154,000 in 2015.
- The industry's total revenue was BGN 8,122,220,000 in 2015, down by 1.98% compared to the previous year.
- The combined costs of the companies in the Manufacture of basic metals industry reached BGN 7,996,910,000 in 2015, down by 2.80% year-on-year.
- The industry's total revenue makes up 10.06% to the country's Gross domestic product (GDP) in 2015, compared to 10.64% for 2014 and 10.22% in 2013.
- A total of 11,878 people were employed in the Manufacture of basic metals industry in 2015, compared to 11,260 in 2014 and 10,812 in 2013.
- Most of the companies in the industry are based in Sofia, followed by Plovdiv and Ruse.

II. INTRODUCTION

In 2015 the companies in the Manufacture of basic metals industry numbered 199, distributed in 14 sectors.






In 2014 there were a total of 198 companies operating in the industry. In 2013 their number totalled 192.

III. REVENUES


The total revenue in the industry was BGN 8,122,220,000 in 2015, BGN 8,286,296,000 in 2014 and 7,859,871,000 in 2013.



The companies in the Manufacture of basic metals market of Bulgaria earned combined net sales revenues of BGN 7,444,488,000 in 2015.

In annual terms, sales marked a fall of 0.68% compared to 2014. In comparison to 2013 they increased by 1.28%. In 2014 sales increased by 1.97% year-on-year.

The Manufacture of basic metals industry total revenue make up 10.06% to the country's GDP in 2015, compared to 10.64% for 2014 and 10.22% in 2013.



In 2015 the Manufacture of basic metals industry contributed to GDP BGN 7,271,505,000 in Gross value added (GVA) accounting for 4.7% of the total for the country's economy.

In the previous year, the industry's GVA amounted BGN 7,827,943,000, accounting for 5.45% of the total for the country in 2014. In 2013 the GVA of the Manufacture of basic metals was BGN 7,374,586,000, or 5.45% of the GVA for the country's economy.







IV. EXPENSES

The combined costs of the companies in the Manufacture of basic metals industry reached BGN 7,996,910,000 in 2015.



In annual terms, total expenses fell by 2.80% compared to 2014 and went up by 1.59% in comparison to 2013.

The total operating expenses of the companies in the Manufacture of basic metals industry were BGN 7,613,957,000 in 2015.

Operating costs rose by 0.97% compared with the previous


year and went up by 1.81% when compared to 2013.

INDUSTRY'S TOTAL COSTS STRUCTURE BY SECTORS




Cold drawing of wire marked the highest annual rise in total expenses, of 1,094.00%, while total expenses fell the most, by 65.98%, for Precious metals production.

In terms of operating expenses, the highest growth, of 1,021.37%, was recorded by the Cold drawing of wire sector. The sharpest decline was posted by Precious metals production - 66.50%.

The biggest spenders in the industry, with costs of over 10% of industry's costs, numbered 4, including SOFIA MED AD, AURUBIS BULGARIA AD (FORMERLY KNOWN AS CUMERIO MED AD), KCM AD, STOMANA - INDUSTRY AD. The medium

spenders, or those in the 5% and 10% range count 2 and include ALCOMET AD, PROMET STEEL AD. Below 5% threshhold are 193 companies, including DIYANA EOOD, SAM TRADING 2008 OOD, Stolekom AD, Precizno Leene AD, ZMM METALIK LEYARNA OOD.

Employment expenses in the Manufacture of basic metals industry grew by 5.44% on the year to BGN 215,564,000 in 2015.



The highest growth in labour costs, of 642.49%, was registered by Cold drawing of wire, while Precious metals production marked the sharpest fall, of 30.65%.

The monthly costs per employee in the Manufacture of basic metals industry averaged BGN 1,512 in 2015, BGN 1,513 in 2014 and BGN 1,382 in 2013.

The monthly social security costs per employee in the industry averaged BGN 286 in 2015, versus BGN 288 in 2014 and BGN 263 in 2013.









About 10.00% of the 10 leading companies in terms of net profit per employee are located in SEVLIEVO, while 10.00% are KAZANLAK-based and 10.00% are headquartered in SOFIA.

The average net sales revenue per employee in the Manufacture of basic metals industry amounted to BGN 626,746 in 2015, down by 5.84% compared to 2014 and down by 7.81% compared to 2013.

The industry's average operating revenue per employee decreased by 3.19% year-on-year in 2015 to BGN 665,345. It fell by 4.16% compared to 2013.

The Manufacture of basic metals industry generated an average BGN 683,804 in total revenue per employee. In 2014 and 2013 the figure was BGN 735,906 and BGN 726,958, respectively.

The average total revenue per company in the Manufacture of basic metals industry decreased to BGN 40,815,176 in 2015 from BGN 41,849,980 in 2014. The 2013 value was BGN 40,936,828.






