


#### I. KEY INDICATORS

- The Manufacture of computer, electronic and optical products industry in Bulgaria was represented by 384 companies at the end of 2016, compared to 404 in the previous year and 377 in 2014.
- The industry's net profit amounted to BGN 111,683,000 in 2016.
- The industry's total revenue was BGN 1,067,148,000 in 2016, up by 12.82% compared to the previous year.
- The combined costs of the companies in the Manufacture of computer, electronic and optical products industry reached BGN 941,036,000 in 2016, up by 14.92% year-onyear.
- The industry's total revenue makes up 1.15% to the country's Gross domestic product (GDP) in 2016, compared to 1.06% for 2015 and 0.91% in 2014.
- A total of 9,072 people were employed in the Manufacture of computer, electronic and optical products industry in 2016, compared to 8,924 in 2015 and 8,374 in 2014.
- Most of the companies in the industry are based in Sofia, followed by Plovdiv and Varna.

#### II. INTRODUCTION

In 2016 the companies in the Manufacture of computer, electronic and optical products industry numbered 384, distributed in 10 sectors.








In 2015 there were a total of 404 companies operating in the industry. In 2014 their number totalled 377.



#### III. REVENUES

The total revenue in the industry was BGN 1,067,148,000 in 2016, BGN 945,849,000 in 2015 and 784,814,000 in 2014.



The Manufacture of computer, electronic and optical products industry total revenue make up 1.15% to the country's GDP in 2016, compared to 1.06% for 2015 and 0.91% in 2014.



In 2016 the Manufacture of computer, electronic and optical products industry contributed to GDP BGN 986,864,000 in Gross value added (GVA) accounting for 0.65% of the total for the country's economy.

In the previous year, the industry's GVA amounted BGN 878,370,000, accounting for 0.57% of the total for the country in 2015. In 2014 the GVA of the Manufacture of computer, electronic and optical products was BGN 731,408,000, or 0.51% of the GVA for the country's economy.





#### IV. EXPENSES

The combined costs of the companies in the Manufacture of computer, electronic and optical products industry reached BGN 941,036,000 in 2016.



In annual terms, total expenses grew by 14.92% compared to 2015 and went up by 40.26% in comparison to 2014.


The total operating expenses of the companies in the Manufacture of computer, electronic and optical products industry were BGN 913,007,000 in 2016.

Operating costs increased by 16.31% compared with the previous year and grew by 40.82% when compared to 2014.

We expect, based on the trend in the last three years, the total costs of the Manufacture of computer, electronic and optical products industry to change at a compound annual growth rate (CAGR) of 18.43% in 2017.




Manufacture of communication equipment marked the highest annual growth in total expenses, of 61.69%, while total expenses dropped the most, by 26.98%, for Manufacture of magnetic and optical media.

In terms of operating expenses, the highest growth, of 64.13%, was recorded by the Manufacture of communication equipment sector. The sharpest decline was posted by Manufacture of magnetic and optical media - 25.93%.

The biggest spenders in the industry, with costs of over 10% of industry's costs, numbered 27, including ELECTROSPHERE EOOD, SAMEL 90 AD, UNIPOS OOD, TREMOL SMD OOD, LEM BULGARIA EOOD. The medium spenders, or those in the 5% and 10% range count 13 and include MILKOTRONIC OOD, SECURITY SMART SYSTEMS OOD, INCOTEX TRADE EUROPE OOD, TCHERNO MORE AD, IMPERX EOOD. Below 5% threshhold are 344 companies, including SONIKS OOD, NOVI TEHNOLOGII I SISTEMI SELEKT PETKO VATEV ET, EC C MS OOD, COMPUTER MARKET EOOD, EASYRAD ELECTRONICS EOOD.

Employment expenses in the Manufacture of computer, electronic and optical products industry increased by 10.80% on the year to BGN 176,762,000 in 2016.



The highest growth in labour costs, of 38.91%, was registered by Manufacture of irradiation, electromedical and electrotherapeutic equipment, while Manufacture of computers and peripheral equipment marked the sharpest fall, of 22.91%.

The monthly costs per employee in the Manufacture of computer, electronic and optical products industry averaged BGN 1,624 in 2016, BGN 1,490 in 2015 and BGN 1,327 in 2014.

The monthly social security costs per employee in the industry averaged BGN 213 in 2016, versus BGN 193 in 2015 and BGN 178 in 2014.



About 40.00% of the 10 leading companies in terms of net profit per employee are located in SOFIA, while 10.00% are STARA ZAGORA-based and 10.00% are headquartered in PETRICH.

The average net sales revenue per employee in the Manufacture of computer, electronic and optical products industry amounted to BGN 109,391 in 2016, up by 13.12% compared to 2015 and up by 26.47% compared to 2014.

The industry's average operating revenue per employee rose by 12.77% year-on-year in 2016 to BGN 116,466. It grew by 26.55% compared to 2014.

The Manufacture of computer, electronic and optical products sector generated an average BGN 117,631 in total revenue per employee. In 2015 and 2014 the figure was BGN 105,989 and BGN 93,720, respectively.

The average total revenue per company in the Manufacture of computer, electronic and optical products industry rose to BGN 2,779,031 in 2016 from BGN 2,341,210 in 2015. The 2014 value was BGN 2,081,735.

A company in the Manufacture of computer, electronic and optical products sector made on average a net sales revenue of BGN 2,584,354 in 2016, compared to BGN 2,136,153 in 2015 and BGN 1,921,196 in 2014.

The Manufacture of computer, electronic and optical products industry made 0.40% of the overall sales countrywide, increasing its market share by 0.06 pp.




