


I. KEY INDICATORS

- The Manufacture of motor vehicles, trailers and semitrailers industry in Bulgaria was represented by 119 companies at the end of 2017, compared to 125 in the previous year and 121 in 2015.
- The industry's net profit amounted to BGN 94,054,000 in 2017.
- The industry's total revenue was BGN 2,135,603,000 in 2017, up by 6.69% compared to the previous year.
- The combined costs of the companies in the Manufacture of motor vehicles, trailers and semi-trailers industry reached BGN 2,029,857,000 in 2017, up by 7.98% year-on-year.
- The industry's total revenue makes up 2.22% to the country's Gross domestic product (GDP) in 2017, compared to 2.16% for 2016 and 2.16% in 2015.
- A total of 21,694 people were employed in the Manufacture of motor vehicles, trailers and semi-trailers industry in 2017, compared to 21,927 in 2016 and 20,924 in 2015.
- Most of the companies in the industry are based in Sofia, followed by Plovdiv and Dobrich.

II. INTRODUCTION

In 2017 the companies in the Manufacture of motor vehicles, trailers and semi-trailers industry numbered 119, distributed in 3 sectors.



III. REVENUES

The total revenue in the industry was BGN 2,135,603,000 in 2017, BGN 2,001,686,000 in 2016 and 1,927,837,000 in 2015.




The companies in the Manufacture of motor vehicles, trailers and semi-trailers market of Bulgaria earned combined net sales revenues of BGN 2,045,305,000 in 2017.

In annual terms, sales marked an increase of 5.88% compared to 2016. In comparison to 2015 they went up by 12.22%. In 2016 sales went up by 5.99% year-on-year.

The Manufacture of motor vehicles, trailers and semi-trailers industry total revenue make up 2.22% to the country's GDP in 2017, compared to 2.16% for 2016 and 2.16% in 2015.

In 2017 the Manufacture of motor vehicles, trailers and semi-trailers industry contributed to GDP BGN 2,033,100,000 in Gross value added (GVA) accounting for 1.19% of the total for the country's economy.


In the previous year, the industry's GVA amounted BGN 1,910,232,000, accounting for 1.25% of the total for the country in 2016. In 2015 the GVA of the Manufacture of motor vehicles, trailers and semi-trailers was BGN 1,766,549,000, or 1.14% of the GVA for the country's economy.

We expect, based on the trend in the last three years, the total revenue of the Manufacture of motor vehicles, trailers and semi-trailers industry to change at a compound annual growth rate (CAGR) of 5.25% in 2018.

Manufacture of electrical and electronic equipment for motor vehicles contributed net sales revenue of BGN 1,328,410,000 or 64.95% of the total net sales in the industry, sector Manufacture of other parts and accessories for motor vehicles - BGN 687,621,000 (33.62%), and sector Manufacture of bodies (coachwork) for motor vehicles; manufacture of trailers and semi-trailers - BGN 29,274,000 (1.43%).



The highest growth, of 17.26%, was recorded by Manufacture of bodies (coachwork) for motor vehicles; manufacture of trailers and semi-trailers. There was no industry's sector to report a drop in net sales revenues.

The total revenues of the top 10 companies in the Manufacture of motor vehicles, trailers and semi-trailers were 1.98% of GDP in 2017, compared to 1.93% for 2016 and 1.87% in 2015.

The top 10 by assets in the Manufacture of motor vehicles, trailers and semi-trailers market made up BGN 1,749,948,000, or 85.56% of the total net sales revenue.



The 10 largest companies in terms of total revenue in sector Manufacture of electrical and electronic equipment for motor vehicles earned total revenue of BGN 1,365,883,000 and accounted for 63.96% of the industry's total revenue.

IV. EXPENSES

The combined costs of the companies in the Manufacture of motor vehicles, trailers and semi-trailers industry reached BGN 2.029.857.000 in 2017.




In annual terms, total expenses grew by 7.98% compared to 2016 and grew by 12.96% in comparison to 2015.

The total operating expenses of the companies in the Manufacture of motor vehicles, trailers and semi-trailers industry were BGN 2,017,119,000 in 2017.

Operating costs increased by 8.27% compared with the previous year and rose by 13.37% when compared to 2015.

We expect, based on the trend in the last three years, the total costs of the Manufacture of motor vehicles, trailers and semi-trailers industry to change at a compound annual growth rate (CAGR) of 6.28% in 2018.

Manufacture of electrical and electronic equipment for motor vehicles reported the highest total costs, of BGN 1,333,198,000, followed by Manufacture of other parts and accessories for motor vehicles with BGN 667,565,000 and Manufacture of bodies (coachwork) for motor vehicles; manufacture of trailers and semi-trailers with total costs of BGN 29,094,000.




Manufacture of electrical and electronic equipment for motor vehicles marked the highest annual growth in total expenses, of 10.49%, while total expenses decreased the most, by 0.97%, for Manufacture of bodies (coachwork) for motor vehicles; manufacture of trailers and semi-trailers.

In terms of operating expenses, the highest growth, of 15.02%, was recorded by the Manufacture of bodies (coachwork) for motor vehicles; manufacture of trailers and semi-trailers sector.

The biggest spenders in the industry, with costs of over 10% of industry's costs, numbered 10, including WITTE AUTOMOTIVE BULGARIA EOOD, KOSTAL BULGARIA AUTOMOTIVE EOOD, GRAMMER AD, SE BORDNETZE BULGARIA EOOD, YAZAKI BULGARIA EOOD. The medium spenders, or those in the 5% and 10% range count 2 and include WILLI ELBE AUTOMOTIVE BULGARIA EOOD, AUTOMOBILE COMPONENT BULGARIA EOOD. Below 5% threshhold are 107 companies, including FEROBUL OOD, VAAS - ASEN POPOV ET, ARZ - POBEDA AD AD, VALEO AUTOPRO EOOD, SANDRA-I- ALEXANDER STUMBOV ET.

Employment expenses in the Manufacture of motor vehicles, trailers and semi-trailers industry went up by 17.78% on the year to BGN 312,493,000 in 2017.



The highest growth in labour costs, of 21.14%, was registered by Manufacture of electrical and electronic equipment for motor vehicles.

The monthly costs per employee in the Manufacture of motor vehicles, trailers and semi-trailers industry averaged BGN 1,200 in 2017, BGN 1,008 in 2016 and BGN 936 in 2015.

The monthly social security costs per employee in the industry averaged BGN 186 in 2017, versus BGN 154 in 2016 and BGN 146 in 2015.







About 40.00% of the 10 leading companies in terms of net profit per employee are located in PLOVDIV, while 20.00% are RUSE-based and 10.00% are headquartered in MOKRISHTE.

The average net sales revenue per employee in the Manufacture of motor vehicles, trailers and semi-trailers industry amounted to BGN 94,280 in 2017, up by 7.01% compared to 2016 and up by 8.23% compared to 2015.

The industry's average operating revenue per employee went up by 8.22% year-on-year in 2017 to BGN 98,228. It rose by 7.02% compared to 2015.

The Manufacture of motor vehicles, trailers and semi-trailers industry generated an average BGN 98,442 in total revenue per employee. In 2016 and 2015 the figure was BGN 91,289 and BGN 92,135, respectively.

The average total revenue per company in the Manufacture of motor vehicles, trailers and semi-trailers industry rose to BGN 17,946,244 in 2017 from BGN 16,013,488 in 2016. The 2015 value was BGN 15,932,537.

A company in the Manufacture of motor vehicles, trailers and semi-trailers industry made on average a net sales revenue of BGN 17,187,437 in 2017, compared to BGN 15,454,240 in 2016 and BGN 15,063,017 in 2015.

The Manufacture of motor vehicles, trailers and semi-trailers industry made 0.75% of the overall sales country-wide, reducing its market share by 0.03 pp.

Operating profit per employee for the industry as a whole was BGN 4,874 in 2017. For comparison in 2016 it amounted to BGN 5,555 and BGN 5,555 in 2015.

Debt-to-assets ratio of the companies in the industry is 0.54 in 2017. It was 0.46 in 2016 and 0.46 in 2015.

In 2017 it stood at BGN 63,246,000, according to the financial statements of the companies in the industry. In 2016 the figure was BGN 61,848,000 and BGN 55,694,000 in 2015.


VI. EMPLOYMENT

ALLOCATION OF EMPLOYEES BY INDUSTRY'S SECTORS





The Manufacture of motor vehicles, trailers and semi-trailers industry is the 23rd largest employer in the country with 21,694 employees with the largest employer being Retail trade, except of motor vehicles and motorcycles with 200,534 and Extraction of crude petroleum and natural gas at the bottom with 27 employees.

The Manufacture of motor vehicles, trailers and semi-trailers's share in the country's total employment was 0.94% in 2017, 1.14% in 2016 and 1.05% in 2015.

We expect, based on the trend in the last three years, the number of employees of the Manufacture of motor vehicles, trailers and semi-trailers industry to change at a compound annual growth rate (CAGR) of 1.82% in 2018.
