


I. KEY INDICATORS


- The Manufacture of other transport equipment industry in Bulgaria was represented by 87 companies at the end of 2016, compared to 76 in the previous year and 69 in 2014.
- The industry's net profit amounted to BGN 39,555,000 in 2016.
- The industry's total revenue was BGN 609,439,000 in 2016, down by 1.48% compared to the previous year.
- The combined costs of the companies in the Manufacture of other transport equipment industry reached BGN 565,142,000 in 2016, down by 2.40% year-on-year.
- The industry's total revenue makes up 0.66% to the country's Gross domestic product (GDP) in 2016, compared to 0.69% for 2015 and 0.66% in 2014.
- A total of 4,844 people were employed in the Manufacture of other transport equipment industry in 2016, compared to 4,837 in 2015 and 4,740 in 2014.
- Most of the companies in the industry are based in Sofia, followed by Varna and Plovdiv.

II. INTRODUCTION

In 2016 the companies in the Manufacture of other transport equipment industry numbered 87, distributed in 6 sectors.








In 2015 there were a total of 76 companies operating in the industry. In 2014 their number totalled 69.



III. REVENUES

The total revenue in the industry was BGN 609,439,000 in 2016, BGN 618,567,000 in 2015 and 571,196,000 in 2014.



The Manufacture of other transport equipment industry total revenue make up 0.66% to the country's GDP in 2016, compared to 0.69% for 2015 and 0.66% in 2014.



In 2016 the Manufacture of other transport equipment industry contributed to GDP BGN 561,134,000 in Gross value added (GVA) accounting for 0.37% of the total for the country's economy.

In the previous year, the industry's GVA amounted BGN 565,332,000, accounting for 0.37% of the total for the country in 2015. In 2014 the GVA of the Manufacture of other transport equipment was BGN 525,060,000, or 0.37% of the GVA for the country's economy.





In annual terms, total expenses dropped by 2.40% compared to 2015 and rose by 4.11% in comparison to 2014.

The total operating expenses of the companies in the Manufacture of other transport equipment industry were BGN 550,211,000 in 2016.

Operating costs went down by 1.68% compared with the previous year and grew by 5.60% when compared to 2014.



IV. EXPENSES

The combined costs of the companies in the Manufacture of




Manufacture of air and spacecraft and related machinery marked the highest annual increase in total expenses, of 618.44%, while total expenses decreased the most, by 28.95%, for Building of ships and floating structures.

In terms of operating expenses, the highest growth, of 596.57%, was recorded by the Manufacture of air and spacecraft and related machinery sector. The sharpest fall was posted by Building of ships and floating structures - 25.34%.

The biggest spenders in the industry, with costs of over 10% of industry's costs, numbered 9, including CROSS OOD, MAXCOM EOOD, TRANSWAGON AD, TRAKTSIA AD, ULA OOD. The medium spenders, or those in the 5% and 10% range count 4 and include BALKANVELO AD, ULBEX OOD, VELOTEC EOOD, VELOMANIA EOOD. Below 5% threshhold are 74 companies, including AIRKOM OOD, ADLERVERKE OOD, LODKOSTROITEL K OOD, ET FAMPI-STEFAN FAMPARSKI, SOTIRA EOOD.

Employment expenses in the Manufacture of other transport equipment industry rose by 7.07% on the year to BGN 70,267,000 in 2016.



The highest growth in labour costs, of 616.67%, was registered by Manufacture of air and spacecraft and related machinery, while Building of ships and floating structures marked the sharpest fall, of 31.52%.

The monthly costs per employee in the Manufacture of other transport equipment industry averaged BGN 1,209 in 2016, BGN 1,131 in 2015 and BGN 1,051 in 2014.

The monthly social security costs per employee in the industry averaged BGN 191 in 2016, versus BGN 178 in 2015 and BGN 160 in 2014.





The Manufacture of other transport equipment's return on assets (ROA) was 8.44%, while in 2015 it amounted to 6.01% and 4.69% in 2014.

About 30.00% of the 10 leading companies in terms of net profit per employee are located in VARNA, while 30.00% are SOFIA-based and 20.00% are headquartered in MONTANA.

The average net sales revenue per employee in the Manufacture of other transport equipment industry amounted to BGN 112,063 in 2016, down by 3.85% compared to 2015 and up by 7.76% compared to 2014.

The industry's average operating revenue per employee went down by 1.87% year-on-year in 2016 to BGN 122,777. It rose by 3.07% compared to 2014.

The Manufacture of other transport equipment field generated an average BGN 125,813 in total revenue per employee. In 2015 and 2014 the figure was BGN 127,882 and BGN 120,505, respectively.

The average total revenue per company in the Manufacture of other transport equipment industry fell to BGN 7,005,046 in 2016 from BGN 8,139,039 in 2015. The 2014 value was BGN 8,278,203.

A company in the Manufacture of other transport equipment market made on average a net sales revenue of BGN 6,239,448 in 2016, compared to BGN 7,417,421 in 2015 and BGN 7,144,043 in 2014.

The Manufacture of other transport equipment industry made 0.22% of the overall sales country-wide, decreasing its market share by 0.01 pp.

Operating profit per employee for the industry as a whole was BGN 9,145 in 2016. For comparison in 2015 it amounted to BGN 8,209 and BGN 8,209 in 2014.






