


#### I. KEY INDICATORS

- The Manufacture of other transport equipment industry in Bulgaria was represented by 88 companies at the end of 2017, compared to 87 in the previous year and 76 in 2015.
- The industry's net profit amounted to BGN 38,348,000 in 2017.
- The industry's total revenue was BGN 632,084,000 in 2017, up by 3.72% compared to the previous year.
- The combined costs of the companies in the Manufacture of other transport equipment industry reached BGN 589,501,000 in 2017, up by 4.31% year-on-year.
- The industry's total revenue makes up 0.73% to the country's Gross domestic product (GDP) in 2017, compared to 0.73% for 2016 and 0.77% in 2015.
- A total of 4,636 people were employed in the Manufacture of other transport equipment industry in 2017, compared to 4,844 in 2016 and 4,837 in 2015.
- Most of the companies in the industry are based in Sofia, followed by Varna and Plovdiv.

# II. INTRODUCTION

In 2017 the companies in the Manufacture of other transport equipment industry numbered 88, distributed in 7 sectors.






In 2016 there were a total of 87 companies operating in the industry. In 2015 their number totalled 76.



#### III. REVENUES

The total revenue in the industry was BGN 632,084,000 in 2017, BGN 609,439,000 in 2016 and 618,567,000 in 2015.



The Manufacture of other transport equipment industry total revenue make up 0.73% to the country's GDP in 2017, compared to 0.73% for 2016 and 0.77% in 2015.



In 2017 the Manufacture of other transport equipment industry contributed to GDP BGN 598,678,000 in Gross value added (GVA) accounting for 0.35% of the total for the country's economy.

In the previous year, the industry's GVA amounted BGN 561,134,000, accounting for 0.37% of the total for the country in 2016. In 2015 the GVA of the Manufacture of other transport equipment was BGN 565,332,000, or 0.37% of the GVA for the country's economy.



The highest growth, of 276.83%, was recorded by Building of pleasure and sporting boats, while Manufacture of air and spacecraft and related machinery registered the sharpest decline, of 35.64%.



## IV. EXPENSES

The combined costs of the companies in the Manufacture of other transport equipment industry reached BGN 589,501,000 in 2017.



In annual terms, total expenses went up by 4.31% compared to 2016 and increased by 1.81% in comparison to 2015.


The total operating expenses of the companies in the Manufacture of other transport equipment industry were BGN 580,226,000 in 2017.

Operating costs rose by 5.46% compared with the previous year and increased by 3.69% when compared to 2015.

We expect, based on the trend in the last three years, the total costs of the Manufacture of other transport equipment industry to change at a compound annual growth rate (CAGR) of 0.90% in 2018.




Building of pleasure and sporting boats marked the highest annual increase in total expenses, of 192.49%.

In terms of operating expenses, the highest increase, of 198.79%, was recorded by the Building of pleasure and sporting boats sector.

The biggest spenders in the industry, with costs of over 10% of industry's costs, numbered 9, including CROSS OOD, TRAKTSIA AD, MAKSKOM EOOD, ULA OOD, SPRINTER OOD. The medium spenders, or those in the 5% and 10% range count 3 and include ULBEX OOD, VELOTEK OOD, VELOMANIA OOD. Below 5% threshhold are 76 companies, including AIRKOM OOD, ADLERVERKE OOD, LODKOSTROITEL-K OOD, SOTIRA OOD, ITK ILIEV OOD.

Employment expenses in the Manufacture of other transport equipment industry increased by 23.06% on the year to BGN 86,472,000 in 2017.



The highest growth in labour costs, of 232.45%, was registered by Building of pleasure and sporting boats, while Manufacture of other transport equipment n.e.c. marked the sharpest fall, of 0.39%.

The monthly costs per employee in the Manufacture of other transport equipment industry averaged BGN 1,554 in 2017, BGN 1,209 in 2016 and BGN 1,131 in 2015.

The monthly social security costs per employee in the industry averaged BGN 221 in 2017, versus BGN 191 in 2016 and BGN 178 in 2015.





The industry's net profit amounted to BGN 38,348,000 in 2017, compared to a net profit of BGN 39,555,000 in 2016 and a net profit of BGN 32,957,000 in 2015.







The Manufacture of other transport equipment industry's return on equity (ROE) is 16.23% compared to 18.94% in 2016 and 13.92% in 2015.

The Manufacture of other transport equipment's return on assets (ROA) was 7.51%, while in 2016 it amounted to 8.44% and 6.01% in 2015.

About 20.00% of the 10 leading companies in terms of net profit per employee are located in LOVECH, while 20.00% are SOFIA-based and 20.00% are headquartered in MONTANA.

The average net sales revenue per employee in the Manufacture of other transport equipment industry amounted to BGN 121,016 in 2017, up by 7.99% compared to 2016 and up by 3.84% compared to 2015.

The industry's average operating revenue per employee increased by 8.57% year-on-year in 2017 to BGN 133,301. It rose by 6.54% compared to 2015.

The Manufacture of other transport equipment market generated an average BGN 136,343 in total revenue per employee. In 2016 and 2015 the figure was BGN 125,813 and BGN 127,882, respectively.

The average total revenue per company in the Manufacture of other transport equipment industry increased to BGN 7,182,773 in 2017 from BGN 7,005,046 in 2016. The 2015 value was BGN 8,139,039.

A company in the Manufacture of other transport equipment industry made on average a net sales revenue of BGN 6,375,318 in 2017, compared to BGN 6,239,448 in 2016 and BGN 7,417,421 in 2015.

The Manufacture of other transport equipment industry made 0.21% of the overall sales country-wide, reducing its market share by 0.01 pp.


#### VI. EMPLOYMENT



The Manufacture of other transport equipment industry is the 60th largest employer in the country with 4,636 employees with the largest employer being Retail trade, except of motor vehicles and motorcycles with 200,534 and Extraction of crude petroleum and natural gas at the bottom with 27 employees.

The Manufacture of other transport equipment's share in the country's total employment was 0.20% in 2017, 0.25% in 2016 and 0.24% in 2015.
