


I. KEY INDICATORS

- The Manufacture of other transport equipment industry in Bulgaria was represented by 81 companies at the end of 2018, compared to 88 in the previous year and 87 in 2016.
- The industry's net profit amounted to BGN 29,220,000 in 2018.
- The industry's total revenue was BGN 886,102,000 in 2018, up by 40.19% compared to the previous year.
- The combined costs of the companies in the Manufacture of other transport equipment industry reached BGN 852,718,000 in 2018, up by 44.65% year-on-year.
- The industry's total revenue makes up 0.90% to the country's Gross domestic product (GDP) in 2018, compared to 0.66% for 2017 and 0.66% in 2016.
- A total of 5,353 people were employed in the Manufacture of other transport equipment industry in 2018, compared to 4,636 in 2017 and 4,844 in 2016.
- Most of the companies in the industry are based in Sofia, followed by Varna and Plovdiv.

II. INTRODUCTION

In 2018 the companies in the Manufacture of other transport equipment industry numbered 81, distributed in 7 sectors.






In 2017 there were a total of 88 companies operating in the industry. In 2016 their number totalled 87.



III. REVENUES

The total revenue in the industry was BGN 886,102,000 in 2018, BGN 632,084,000 in 2017 and 609,439,000 in 2016.



The Manufacture of other transport equipment industry total revenue make up 0.9% to the country's GDP in 2018, compared to 0.66% for 2017 and 0.66% in 2016.



In 2018 the Manufacture of other transport equipment industry contributed to GDP BGN 855,955,000 in Gross value added (GVA) accounting for 0.47% of the total for the country's economy.

In the previous year, the industry's GVA amounted BGN 598,678,000, accounting for 0.35% of the total for the country in 2017. In 2016 the GVA of the Manufacture of other transport equipment was BGN 561,134,000, or 0.37% of the GVA for the country's economy.





The highest growth, of 255.22%, was recorded by Manufacture of air and spacecraft and related machinery, while Manufacture of other transport equipment n.e.c. registered the sharpest decline, of 99.51%.

The total revenues of the top 10 companies in the Manufacture of other transport equipment were 0.81% of GDP in 2018, compared to 0.57% for 2017 and 0.57% in 2016.



IV. EXPENSES

The combined costs of the companies in the Manufacture of other transport equipment industry reached BGN 852,718,000 in 2018.



In annual terms, total expenses increased by 44.65% compared to 2017 and grew by 50.89% in comparison to 2016.


The total operating expenses of the companies in the Manufacture of other transport equipment industry were BGN 843,164,000 in 2018.

Operating costs went up by 45.32% compared with the previous year and rose by 53.24% when compared to 2016.

We expect, based on the trend in the last three years, the total costs of the Manufacture of other transport equipment industry to change at a compound annual growth rate (CAGR) of 22.84% in 2019.




Manufacture of air and spacecraft and related machinery marked the highest annual rise in total expenses, of 362.14%, while total expenses went down the most, by 99.29%, for Manufacture of other transport equipment n.e.c..

In terms of operating expenses, the highest growth, of 371.93%, was recorded by the Manufacture of air and spacecraft and related machinery sector. The sharpest drop was posted by Manufacture of other transport equipment n.e.c. - 99.29%.

The biggest spenders in the industry, with costs of over 10% of industry's costs, numbered 7, including CROSS OOD, MAXCOM EOOD, MTG-DOLPHIN AD, ULA OOD, LEADER 96 EOOD. The medium spenders, or those in the 5% and 10% range count 4 and include ULBEX OOD, VELOTEC EOOD, TRAKTSIA AD, SPRINTER OOD. Below 5% threshhold are 70 companies, including AIRKOM OOD, LODKOSTROITEL KOOD, PLAM I PRES EOOD, SOTIRA EOOD, DIMITAR KOZHUHAROV ET.

Employment expenses in the Manufacture of other transport equipment industry grew by 39.71% on the year to BGN 120,809,000 in 2018.



The highest growth in labour costs, of 296.29%, was registered by Manufacture of air and spacecraft and related machinery, while Manufacture of other transport equipment n.e.c. marked the sharpest fall, of 98.41%.

The monthly costs per employee in the Manufacture of other transport equipment industry averaged BGN 1,881 in 2018, BGN 1,554 in 2017 and BGN 1,209 in 2016.

The monthly social security costs per employee in the industry averaged BGN 276 in 2018, versus BGN 221 in 2017 and BGN 191 in 2016.





The industry's net profit amounted to BGN 29,220,000 in 2018, compared to a net profit of BGN 38,348,000 in 2017 and a net profit of BGN 39,555,000 in 2016.







The Manufacture of other transport equipment industry's return on equity (ROE) is 8.81% compared to 16.23% in 2017 and 18.94% in 2016.

The Manufacture of other transport equipment's return on assets (ROA) was 4.44%, while in 2017 it amounted to 7.51% and 8.44% in 2016.

About 30.00% of the 10 leading companies in terms of net profit per employee are located in SOFIA, while 20.00% are VARNA-based and 20.00% are headquartered in MONTANA.

The average net sales revenue per employee in the Manufacture of other transport equipment industry amounted to BGN 153,401 in 2018, up by 26.76% compared to 2017 and up by 36.89% compared to 2016.

The industry's average operating revenue per employee rose by 23.47% year-on-year in 2018 to BGN 164,584. It grew by 34.05% compared to 2016.

The Manufacture of other transport equipment industry generated an average BGN 165,534 in total revenue per employee. In 2017 and 2016 the figure was BGN 136,343 and BGN 125,813, respectively.

The average total revenue per company in the Manufacture of other transport equipment industry increased to BGN 10,939,531 in 2018 from BGN 7,182,773 in 2017. The 2016 value was BGN 7,005,046.

A company in the Manufacture of other transport equipment industry made on average a net sales revenue of BGN 10,137,728 in 2018, compared to BGN 6,375,318 in 2017 and BGN 6,239,448 in 2016.

The Manufacture of other transport equipment industry made 0.28% of the overall sales country-wide, rising its market share by 0.08 pp.

Operating profit per employee for the industry as a whole was BGN 6,237 in 2018. For comparison in 2017 it amounted to BGN 9,185 and BGN 9,185 in 2016.


VI. EMPLOYMENT



The Manufacture of other transport equipment industry is the 61st largest employer in the country with 5,353 employees with the largest employer being Retail trade, except of motor vehicles and motorcycles with 222,070 and Extraction of crude petroleum and natural gas at the bottom with 28 employees.

The Manufacture of other transport equipment's share in the country's total employment was 0.23% in 2018, 0.25% in 2017 and 0.25% in 2016.
