# I. KEY INDICATORS

- The Remediation activities and other waste management services industry in Bulgaria was represented by 75 companies at the end of 2015, compared to 71 in the previous year and 65 in 2013.
- The industry's net profit amounted to BGN 6,551,000 in 2015.
- The industry's total revenue was BGN 143,582,000 in 2015, up by 5.69% compared to the previous year.
- The combined costs of the companies in the Remediation activities and other waste management services industry reached BGN 136,306,000 in 2015, up by 4.21% year-on-year.
- The industry's total revenue makes up 0.18% to the country's Gross domestic product (GDP) in 2015, compared to 0.17% for 2014 and 0.15% in 2013.
- A total of 909 people were employed in the Remediation activities and other waste management services industry in 2015, compared to 788 in 2014 and 742 in 2013.
- Most of the companies in the industry are based in Sofia, followed by Plovdiv and Varna.

# **II. INTRODUCTION**

In 2015 the companies in the Remediation activities and other waste management services industry numbered 75.


In 2014 there were a total of 71 companies operating in the industry. In 2013 their number totalled 65.

# III. REVENUES


The total revenue in the industry was BGN 143,582,000 in 2015, BGN 135,854,000 in 2014 and 116,934,000 in 2013.



The companies in the Remediation activities and other waste management services market of Bulgaria earned combined net sales revenues of BGN 134,296,000 in 2015.

In annual terms, sales marked a growth of 7.71% compared to 2014. In comparison to 2013 they increased by 30.75%. In 2014 sales rose by 21.40% year-on-year.

The Remediation activities and other waste management services industry total revenue make up 0.18% to the country's GDP in 2015, compared to 0.17% for 2014 and 0.15% in 2013.



In 2015 the Remediation activities and other waste management services industry contributed to GDP BGN 122,306,000 in Gross value added (GVA) accounting for 0.08% of the total for the country's economy.

116,043,000, accounting for 0.08% of the total for the country in 2014. In 2013 the GVA of the Remediation activities and other waste management services was BGN 99,125,000, or 0.07% of the GVA for the country's economy.

We expect, based on the trend in the last three years, the total revenue of the Remediation activities and other waste management services industry to change at a compound annual growth rate (CAGR) of 10.81% in 2016.

The top 10 companies in terms of total revenue in Remediation activities and other waste management services accounted for 87.76% of the industry's total in 2015, 90.92% in 2014 and 91.81% in 2013.

The total revenues of the top 10 companies in the Remediation activities and other waste management services were 0.16% of GDP in 2015, compared to 0.16% for 2014 and 0.14% in 2013.

The top 10 by assets in the Remediation activities and other waste management services field made up BGN 78,634,000, or 58.55% of the total net sales revenue.



The 10 largest companies in terms of total revenue in sector Remediation activities and other waste management services earned total revenue of BGN 126,011,000 and accounted for 87.76% of the industry's total revenue.

## **IV. EXPENSES**

The combined costs of the companies in the Remediation activities and other waste management services industry reached BGN 136,306,000 in 2015.




In annual terms, total expenses went up by 4.21% compared to 2014 and went up by 20.93% in comparison to 2013.

The total operating expenses of the companies in the Remediation activities and other waste management services industry were BGN 135,353,000 in 2015.

Operating costs increased by 5.46% compared with the previous year and went up by 21.21% when compared to 2013.

We expect, based on the trend in the last three years, the total costs of the Remediation activities and other waste management services industry to change at a compound annual growth rate (CAGR) of 9.97% in 2016.

Employment expenses in the Remediation activities and other waste management services industry went up by 12.91% on the year to BGN 11,279,000 in 2015.



The highest growth in labour costs, of 12.91%, was registered by Remediation activities and other waste management services.


The monthly costs per employee in the Remediation activities and other waste management services industry averaged BGN 1,034 in 2015, BGN 1,056 in 2014 and BGN 1,002 in 2013.

The monthly social security costs per employee in the industry averaged BGN 158 in 2015, versus BGN 156 in 2014 and BGN 147 in 2013.



The industry's tax expenses stood at BGN 725,000 in 2015. In 2014 it paid taxes of BGN 661,000. In 2013 the industry paid BGN 331,000 in taxes.



## V. PROFITABILITY

The industry's net profit amounted to BGN 6,551,000 in 2015, compared to a net profit of BGN 4,397,000 in 2014 and a net profit of BGN 3,886,000 in 2013.



The combined operating earnings of the companies in the Remediation activities and other waste management services market grew by 33.36% y/y to BGN 7,267,000 in 2015.

The profit margin for the Remediation activities and other waste management services industry stood at 5.07% in 2015, while in 2014 it amounted to 4.02% and 3.69% in 2013.

The Remediation activities and other waste management services industry's return on equity (ROE) is 13.69% compared to 10.16% in 2014 and 9.90% in 2013.

The Remediation activities and other waste management services's return on assets (ROA) was 7.12%, while in 2014 it amounted to 4.76% and 4.53% in 2013.

About 20.00% of the 10 leading companies in terms of net profit per employee are located in VARNA, while 10.00% are GALABOVO-based and 10.00% are headquartered in BELOVO.

The average net sales revenue per employee in the Remediation activities and other waste management services industry amounted to BGN 147,740 in 2015, down by 6.63% compared to 2014 and up by 6.73% compared to 2013.

The industry's average operating revenue per employee went down by 8.37% year-on-year in 2015 to BGN 157,686. It grew by 2.07% compared to 2013.

The Remediation activities and other waste management services sector generated an average BGN 157,956 in total revenue per employee. In 2014 and 2013 the figure was BGN 172,404 and BGN 157,593, respectively.

The average total revenue per company in the Remediation activities and other waste management services industry increased to BGN 1,914,427 in 2015 from BGN 1,913,437 in 2014. The 2013 value was BGN 1,798,985.

A company in the Remediation activities and other waste management services market made on average a net sales revenue of BGN 1,790,613 in 2015, compared to BGN 1,756,127 in 2014 and BGN 1,580,154 in 2013.

The Remediation activities and other waste management services industry made 0.05% of the overall sales country-wide.

Operating profit per employee for the industry as a whole was BGN 7,995 in 2015. For comparison in 2014 it amounted to BGN 6,915 and BGN 6,915 in 2013.

The total indebtedness of the companies in the Remediation activities and other waste management services industry was BGN 41,882,000 versus BGN 47,106,000 a year ago. In 2013 the industry's indebtedness totalled BGN 44,144,000.

Debt-to-assets ratio of the companies in the industry is 0.46 in 2015. It was 0.51 in 2014 and 0.52 in 2013.


According to market experts, the greatest impact on the development of the Remediation activities and other waste management services industry has operating profit / loss. In 2015 it stood at BGN 7,267,000, according to the financial statements of the companies in the industry. In 2014 the figure was BGN 5,449,000 and BGN 4,226,000 in 2013.

## **VI. EMPLOYMENT**

A total of 909 people were employed in the Remediation activities and other waste management services market at the end of 2015, compared to 788 in 2014 and 742 in 2013.

The analysis on companies' sizes by the number of employees, shows that 40 firms have less than 50 employees\*, 3 have between 50 and 250 employees\* and 1 companies employ more than 250\*.

\* Companies without data in the number of employees at end of the year are not taken into consideration.



The employees of the leading 10 companies in terms of numbers make up 89.44% of the workforce in the industry in 2015.

The Remediation activities and other waste management services industry is the 74th largest employer in the country with 909 employees with the largest employer being Retail trade, except of motor vehicles and motorcycles with 218,362 and Libraries, archives, museums and other cultural activities at the bottom with 60 employees.

The Remediation activities and other waste management services's share in the country's total employment was 0.04% in 2015, 0.04% in 2014 and 0.03% in 2013.

We expect, based on the trend in the last three years, the number of employees of the Remediation activities and other waste management services industry to change at a compound annual growth rate (CAGR) of 10.68% in 2016.
