I. KEY INDICATORS

- The Sewerage industry in Bulgaria was represented by 67 companies at the end of 2015, compared to 69 in the previous year and 64 in 2013.
- The industry's net profit amounted to BGN 1,438,000 in 2015.
- The industry's total revenue was BGN 17,401,000 in 2015, down by 7.03% compared to the previous year.
- The combined costs of the companies in the Sewerage industry reached BGN 15,744,000 in 2015, down by 2.89% year-on-year.
- The industry's total revenue makes up 0.02% to the country's Gross domestic product (GDP) in 2015, compared to 0.02% for 2014 and 0.02% in 2013.
- A total of 215 people were employed in the Sewerage industry in 2015, compared to 203 in 2014 and 271 in 2013.
- Most of the companies in the industry are based in Sofia, followed by Varna and Burgas.

II. INTRODUCTION

In 2015 the companies in the Sewerage industry numbered 67.


In 2014 there were a total of 69 companies operating in the industry. In 2013 their number totalled 64.

III. REVENUES


The total revenue in the industry was BGN 17,401,000 in 2015, BGN 18,717,000 in 2014 and 13,773,000 in 2013.



The companies in the Sewerage market of Bulgaria earned combined net sales revenues of BGN 16,309,000 in 2015.

In annual terms, sales marked a decline of 6.69% compared to 2014. In comparison to 2013 they rose by 25.83%. In 2014 sales grew by 34.86% year-on-year.

The Sewerage industry total revenue make up 0.02% to the country's GDP in 2015, compared to 0.02% for 2014 and 0.02% in 2013.



In 2015 the Sewerage industry contributed to GDP BGN 15,525,000 in Gross value added (GVA) accounting for 0.01% of the total for the country's economy.

In the previous year, the industry's GVA amounted BGN 16,968,000, accounting for 0.01% of the total for the country in 2014. In 2013 the GVA of the Sewerage was BGN 12,526,000, or 0.01% of the GVA for the country's economy.

We expect, based on the trend in the last three years, the total revenue of the Sewerage industry to change at a compound annual growth rate (CAGR) of 12.40% in 2016.

The top 10 companies in terms of total revenue in Sewerage accounted for 83.08% of the industry's total in 2015, 82.60% in 2014 and 80.53% in 2013.

The total revenues of the top 10 companies in the Sewerage were 0.02% of GDP in 2015, compared to 0.02% for 2014 and 0.01% in 2013.

The top 10 by assets in the Sewerage field made up BGN 12,050,000, or 73.89% of the total net sales revenue.



The 10 largest companies in terms of total revenue in sector Sewerage earned total revenue of BGN 14,457,000 and accounted for 83.08% of the industry's total revenue.

IV. EXPENSES

The combined costs of the companies in the Sewerage industry reached BGN 15,744,000 in 2015.




In annual terms, total expenses decreased by 2.89% compared to 2014 and rose by 29.02% in comparison to 2013.

The total operating expenses of the companies in the Sewerage industry were BGN 15,437,000 in 2015.

Operating costs dropped by 2.79% compared with the previous year and grew by 29.10% when compared to 2013.

We expect, based on the trend in the last three years, the total costs of the Sewerage industry to change at a compound annual growth rate (CAGR) of 13.59% in 2016.

Employment expenses in the Sewerage industry grew by 21.26% on the year to BGN 2,858,000 in 2015.



The highest growth in labour costs, of 21.26%, was registered by Sewerage.


The monthly costs per employee in the Sewerage industry averaged BGN 1,108 in 2015, BGN 968 in 2014 and BGN 716 in 2013.

The monthly social security costs per employee in the industry averaged BGN 163 in 2015, versus BGN 146 in 2014 and BGN 111 in 2013.



The industry's tax expenses stood at BGN 219,000 in 2015. In 2014 it paid taxes of BGN 264,000. In 2013 the industry paid BGN 179,000 in taxes.



V. PROFITABILITY

The industry's net profit amounted to BGN 1,438,000 in 2015, compared to a net profit of BGN 2,240,000 in 2014 and a net profit of BGN 1,391,000 in 2013.



The combined operating earnings of the companies in the Sewerage industry decreased by 33.80% y/y to BGN 1,659,000 in 2015.

The profit margin for the Sewerage industry stood at 9.59% in 2015, while in 2014 it amounted to 13.45% and 11.42% in 2013.

The Sewerage industry's return on equity (ROE) is 8.94% compared to 14.04% in 2014 and 9.43% in 2013.

The Sewerage's return on assets (ROA) was 5.43%, while in 2014 it amounted to 8.09% and 6.14% in 2013.

About 40.00% of the 10 leading companies in terms of net profit per employee are located in SOFIA, while 10.00% are SOZOPOL-based and 10.00% are headquartered in STARA ZAGORA.

The average net sales revenue per employee in the Sewerage industry amounted to BGN 75,856 in 2015, down by 11.90% compared to 2014 and up by 58.61% compared to 2013.

The industry's average operating revenue per employee went down by 12.35% year-on-year in 2015 to BGN 80,433. It rose by 58.99% compared to 2013.

The Sewerage market generated an average BGN 80,935 in total revenue per employee. In 2014 and 2013 the figure was BGN 92,202 and BGN 50,823, respectively.

The average total revenue per company in the Sewerage industry fell to BGN 259,716 in 2015 from BGN 271,261 in 2014. The 2013 value was BGN 215,203.

A company in the Sewerage sector made on average a net sales revenue of BGN 243,418 in 2015, compared to BGN 253,319 in 2014 and BGN 202,516 in 2013.

The Sewerage industry made 0.01% of the overall sales country-wide.

Operating profit per employee for the industry as a whole was BGN 7,716 in 2015. For comparison in 2014 it amounted to BGN 12,345 and BGN 12,345 in 2013.

The total indebtedness of the companies in the Sewerage industry was BGN 8,673,000 versus BGN 10,598,000 a year ago. In 2013 the industry's indebtedness totalled BGN 7,062,000.

Debt-to-assets ratio of the companies in the industry is 0.33 in 2015. It was 0.38 in 2014 and 0.31 in 2013.


According to market experts, the greatest impact on the development of the Sewerage industry has operating profit / loss. In 2015 it stood at BGN 1,659,000, according to the financial statements of the companies in the industry. In 2014 the figure was BGN 2,506,000 and BGN 1,565,000 in 2013.

VI. EMPLOYMENT

A total of 215 people were employed in the Sewerage sector at the end of 2015, compared to 203 in 2014 and 271 in 2013.

The analysis on companies' sizes by the number of employees, shows that 30 firms have less than 50 employees*. 1 have between 50 and 250 employees*.

* Companies without data in the number of employees at end of the year are not taken into consideration.



The employees of the leading 10 companies when it comes to numbers make up 82.33% of the workforce in the industry in 2015.

The Sewerage industry is the 81st largest employer in the country with 215 employees with the largest employer being Retail trade, except of motor vehicles and motorcycles with 218,362 and Libraries, archives, museums and other cultural activities at the bottom with 60 employees.

The Sewerage's share in the country's total employment was 0.01% in 2015, 0.01% in 2014 and 0.01% in 2013.

We expect, based on the trend in the last three years, the number of employees of the Sewerage industry to change at a compound annual growth rate (CAGR) of -10.93% in 2016.
