# I. KEY INDICATORS

- The Water collection, treatment and supply industry in Bulgaria was represented by 69 companies at the end of 2015, compared to 76 in the previous year and 71 in 2013.
- The industry's net profit amounted to BGN 28,947,000 in 2015.
- The industry's total revenue was BGN 672,914,000 in 2015, up by 4.74% compared to the previous year.
- The combined costs of the companies in the Water collection, treatment and supply industry reached BGN 640,295,000 in 2015, up by 2.09% year-on-year.
- The industry's total revenue makes up 0.83% to the country's Gross domestic product (GDP) in 2015, compared to 0.82% for 2014 and 0.87% in 2013.
- A total of 26,624 people were employed in the Water collection, treatment and supply industry in 2015, compared to 17,034 in 2014 and 17,350 in 2013.
- Most of the companies in the industry are based in Sofia, followed by Velingrad and Batak.

# **II. INTRODUCTION**

In 2015 the companies in the Water collection, treatment and supply industry numbered 69.

In 2014 there were a total of 76 companies operating in the industry. In 2013 their number totalled 71.

# III. REVENUES


The total revenue in the industry was BGN 672,914,000 in 2015, BGN 642,447,000 in 2014 and 665,997,000 in 2013.

The companies in the Water collection, treatment and supply market of Bulgaria earned combined net sales revenues of BGN 576,330,000 in 2015.

In annual terms, sales marked a growth of 4.58% compared to 2014. In comparison to 2013 they rose by 1.01%. In 2014 sales increased by 3.41% year-on-year.

The Water collection, treatment and supply industry total revenue make up 0.83% to the country's GDP in 2015, compared to 0.82% for 2014 and 0.87% in 2013.



In 2015 the Water collection, treatment and supply industry contributed to GDP BGN 621,894,000 in Gross value added (GVA) accounting for 0.4% of the total for the country's economy.

In the previous year, the industry's GVA amounted BGN 584,641,000, accounting for 0.41% of the total for the

country in 2014. In 2013 the GVA of the Water collection, treatment and supply was BGN 602,469,000, or 0.45% of the GVA for the country's economy.

We expect, based on the trend in the last three years, the total revenue of the Water collection, treatment and supply industry to change at a compound annual growth rate (CAGR) of 0.52% in 2016.

The top 10 companies in terms of total revenue in Water collection, treatment and supply accounted for 67.58% of the industry's total in 2015, 67.73% in 2014 and 67.57% in 2013.

The total revenues of the top 10 companies in the Water collection, treatment and supply were 0.56% of GDP in 2015, compared to 0.56% for 2014 and 0.59% in 2013.

The top 10 by assets in the Water collection, treatment and supply market made up BGN 377,360,000, or 65.48% of the total net sales revenue.



The 10 largest companies in terms of total revenue in sector Water collection, treatment and supply earned total revenue of BGN 454,782,000 and accounted for 67.58% of the industry's total revenue.

## **IV. EXPENSES**

The combined costs of the companies in the Water collection, treatment and supply industry reached BGN 640,295,000 in 2015.



In annual terms, total expenses increased by 2.09% compared to 2014 and decreased by 0.09% in comparison to 2013.


The total operating expenses of the companies in the Water collection, treatment and supply industry were BGN 628,234,000 in 2015.

Operating costs went up by 2.41% compared with the previous year and went up by 0.69% when compared to 2013.

We expect, based on the trend in the last three years, the total

costs of the Water collection, treatment and supply industry to change at a compound annual growth rate (CAGR) of -0.04% in 2016.

Employment expenses in the Water collection, treatment and supply industry grew by 2.27% on the year to BGN 211,607,000 in 2015.



The highest growth in labour costs, of 2.27%, was registered by Water collection, treatment and supply.


The monthly costs per employee in the Water collection, treatment and supply industry averaged BGN 662 in 2015, BGN 1,012 in 2014 and BGN 953 in 2013.

The monthly social security costs per employee in the industry averaged BGN 139 in 2015, versus BGN 208 in 2014 and BGN 201 in 2013.



The industry's tax expenses stood at BGN 3,672,000 in 2015. In 2014 it paid taxes of BGN 3,011,000. In 2013 the industry paid BGN 3,151,000 in taxes.



## **V. PROFITABILITY**

The industry's net profit amounted to BGN 28,947,000 in 2015, compared to a net profit of BGN 12,247,000 in 2014 and a net profit of BGN 21,979,000 in 2013.



The combined operating earnings of the companies in the Water collection, treatment and supply industry rose by 112.94% y/y to BGN 32,177,000 in 2015.

The profit margin for the Water collection, treatment and supply industry stood at 4.85% in 2015, while in 2014 it amounted to 2.38% and 3.79% in 2013.

The Water collection, treatment and supply industry's return on equity (ROE) is 5.00% compared to 2.18% in 2014 and 4.01% in 2013.

The Water collection, treatment and supply's return on assets (ROA) was 2.48%, while in 2014 it amounted to 1.05% and 1.91% in 2013.

About 20.00% of the 10 leading companies in terms of net profit per employee are located in SOFIA, while 10.00% are RAKOVSKI-based and 10.00% are headquartered in BURGAS.

The average net sales revenue per employee in the Water collection, treatment and supply industry amounted to BGN 21,647 in 2015, down by 33.09% compared to 2014 and down by 34.18% compared to 2013.

The industry's average operating revenue per employee decreased by 33.17% year-on-year in 2015 to BGN 24,927. It fell by 34.42% compared to 2013.

The Water collection, treatment and supply market generated an average BGN 25,275 in total revenue per employee. In 2014 and 2013 the figure was BGN 37,716 and BGN 38,386, respectively.

The average total revenue per company in the Water collection, treatment and supply industry grew to BGN 9,752,377 in 2015 from BGN 8,453,250 in 2014. The 2013 value was BGN 9,380,239.

A company in the Water collection, treatment and supply market made on average a net sales revenue of BGN 8,352,609 in 2015, compared to BGN 7,251,487 in 2014 and BGN 8,036,254 in 2013.

The Water collection, treatment and supply industry made 0.23% of the overall sales country-wide, decreasing its market share by 0.01 pp.

Operating profit per employee for the industry as a whole was BGN 1,209 in 2015. For comparison in 2014 it amounted to BGN 887 and BGN 887 in 2013.

The total indebtedness of the companies in the Water collection, treatment and supply industry was BGN 391,793,000 versus BGN 407,312,000 a year ago. In 2013 the industry's indebtedness totalled BGN 428,831,000.

Debt-to-assets ratio of the companies in the industry is 0.34 in 2015. It was 0.35 in 2014 and 0.37 in 2013.


According to market experts, the greatest impact on the development of the Water collection, treatment and supply industry has accounting profit / loss. In 2015 it stood at BGN 0, according to the financial statements of the companies in the industry.

## **VI. EMPLOYMENT**

A total of 26,624 people were employed in the Water collection, treatment and supply industry at the end of 2015, compared to 17,034 in 2014 and 17,350 in 2013.

The analysis on companies' sizes by the number of employees, shows that 19 firms have less than 50 employees\*, 14 have between 50 and 250 employees\* and 27 companies employ more than 250\*.

\* Companies without data in the number of employees at end of the year are not taken into consideration.



The employees of the leading 10 companies in terms of numbers make up 52.92% of the workforce in the industry in 2015.

The Water collection, treatment and supply industry is the 22nd largest employer in the country with 26,624 employees with the largest employer being Retail trade, except of motor vehicles and motorcycles with 218,362 and Libraries, archives, museums and other cultural activities at the bottom with 60 employees.

The Water collection, treatment and supply's share in the country's total employment was 1.19% in 2015, 0.92% in 2014 and 0.82% in 2013.

We expect, based on the trend in the last three years, the number of employees of the Water collection, treatment and supply industry to change at a compound annual growth rate (CAGR) of 23.88% in 2016.
