


I. KEY INDICATORS

- The Legal and accounting activities industry in Romania was represented by 9,941 companies at the end of 2016, compared to 8,877 in the previous year and 8,443 in 2014.
- The industry's net profit amounted to RON 561,282,179 in 2016.
- The industry's total revenue was RON 2,740,310,214 in 2016, up by 14.52% compared to the previous year.
- The combined costs of the companies in the Legal and accounting activities industry reached RON 2,124,146,101 in 2016, up by 12.31% year-on-year.
- The industry's total revenue makes up 0.29% to the country's Gross domestic product (GDP) in 2016, compared to 0.28% for 2015 and 0.22% in 2014.
- A total of 20,530 people were employed in the Legal and accounting activities industry in 2016, compared to 18,942 in 2015 and 17,288 in 2014.
- Most of the companies in the industry are based in Bucharest, followed by Timis and Brasov.

II. INTRODUCTION

In 2016 the companies in the Legal and accounting activities industry numbered 9,941, distributed in 2 sectors.






In 2015 there were a total of 8,877 companies operating in the industry. In 2014 their number totalled 8,443.

III. REVENUES

The total revenue in the industry was RON 2,740,310,214 in 2016, RON 2,392,848,443 in 2015 and 1,811,229,597 in 2014.




The companies in the Legal and accounting activities market of Romania earned combined net sales revenues of RON 2,654,941,663 in 2016.

In annual terms, sales marked a growth of 15.02% compared to 2015. In comparison to 2014 they grew by 52.03%. In 2015 sales rose by 32.18% year-on-year.

The Legal and accounting activities industry total revenue make up 0.29% to the country's GDP in 2016, compared to 0.28% for 2015 and 0.22% in 2014.



We expect, based on the trend in the last three years, the total revenue of the Legal and accounting activities industry to change at a compound annual growth rate (CAGR) of 23.00% in 2017.

Accounting, bookkeeping and auditing activities; tax consultancy contributed net sales revenue of RON 2,641,108,205 or 99.48% of the total net sales in the industry, and sector Legal activities - RON 13,833,458 (0.52%).

The highest growth, of 31.06%, was recorded by Legal activities. There was no industry's sector to report a drop in net sales revenues.

The top 10 by assets in the Legal and accounting activities market made up RON 957,350,978, or 36.06% of the total net sales revenue.

The 10 largest companies in terms of total revenue in sector Legal and accounting activities earned total revenue of RON 1,068,228,469 and accounted for 38.98% of the industry's total revenue.

IV. EXPENSES


The combined costs of the companies in the Legal and accounting activities industry reached RON 2,124,146,101 in 2016.

In annual terms, total expenses rose by 12.31% compared to 2015 and increased by 47.95% in comparison to 2014.

We expect, based on the trend in the last three years, the total costs of the Legal and accounting activities industry to change at a compound annual growth rate (CAGR) of 21.63% in 2017.

Accounting, bookkeeping and auditing activities; tax consultancy reported the highest total costs, of RON 2,113,349,933, followed by Legal activities with RON 10,796,168.





Legal activities marked the highest annual growth in total expenses, of 26.07%.

The biggest spenders in the industry, with costs of over 10% of industry's costs, numbered 11, including KPMG AUDIT SRL, DELOITTE TAX SRL, ERNST & YOUNG SUPPORT SERVICES SRL, BRITISH AMERICAN SHARED SERVICES (EUROPE) SRL, PRICEWATERHOUSECOOPERS AUDIT SRL. The medium spenders, or those in the 5% and 10% range count 3 and include TMF ROMANIA SRL, MAZARS CONSULTING SRL, AZETS INSIGHT SRL. Below 5% threshhold are 9,927 companies, including C&G FISCAL CONSULTING SERVICES SRL, AMI CONTEXPERT SRL, A&I CONSULTING SRL, PRINTESA EC SRL, PRIM CONTAB EXPERT SRL.

Employment expenses in the Legal and accounting activities industry went up by 24.90% on the year to RON 854,287,987 in 2016.

The highest growth in labour costs, of 24.98%, was registered by Accounting, bookkeeping and auditing activities; tax consultancy.

The monthly costs per employee in the Legal and accounting activities industry averaged RON 3,468 in 2016, RON 3,009 in 2015 and RON 2,324 in 2014.








The Legal and accounting activities industry's return on equity (ROE) is 50.24% compared to 653.16% in 2015 and 35.37% in 2014

About 50.00% of the 10 leading companies in terms of net profit per employee are located in Bucharest, while 20.00% are Bistrita-Nasaud-based and 10.00% are headquartered in Doli

The average net sales revenue per employee in the Legal and accounting activities industry amounted to RON 129,320 in 2016, up by 6.12% compared to 2015 and up by 28.03% compared to 2014.

The Legal and accounting activities sector generated an

average RON 133,478 in total revenue per employee. In 2015 and 2014 the figure was RON 126,325 and RON 104,768, respectively.

The average total revenue per company in the Legal and accounting activities industry increased to RON 275,657 in 2016 from RON 269,556 in 2015. The 2014 value was RON 214,524.

A company in the Legal and accounting activities sector made on average a net sales revenue of RON 267,070 in 2016, compared to RON 260,021 in 2015 and RON 206,831 in 2014.

The Legal and accounting activities industry made 0.22% of the overall sales country-wide, rising its market share by 0.02 pp.


