

# I. KEY INDICATORS

- The Manufacture of paper and paper products industry in Romania was represented by 782 companies at the end of 2016, compared to 765 in the previous year and 730 in 2014.
- The industry's net profit amounted to RON 209,072,472 in 2016.
- The industry's total revenue was RON 4,343,319,402 in 2016, up by 11.70% compared to the previous year.
- The combined costs of the companies in the Manufacture of paper and paper products industry reached RON 4,099,165,504 in 2016, up by 11.93% year-on-year.
- The industry's total revenue makes up 0.47% to the country's Gross domestic product (GDP) in 2016, compared to 0.45% for 2015 and 0.42% in 2014.
- A total of 12,726 people were employed in the Manufacture of paper and paper products industry in 2016, compared to 11,794 in 2015 and 10,955 in 2014.
- Most of the companies in the industry are based in Bucharest, followed by Cluj and Arges.

# **II. INTRODUCTION**

In 2016 the companies in the Manufacture of paper and paper products industry numbered 782, distributed in 7 sectors.




In 2015 there were a total of 765 companies operating in the industry. In 2014 their number totalled 730.

# **III. REVENUES**

The total revenue in the industry was RON 4,343,319,402 in 2016, RON 3,888,480,378 in 2015 and 3,406,830,785 in 2014.




The companies in the Manufacture of paper and paper products market of Romania earned combined net sales revenues of RON 4,179,704,909 in 2016.

In annual terms, sales marked a rise of 12.13% compared to 2015. In comparison to 2014 they went up by 28.91%. In 2015 sales grew by 14.97% year-on-year.

The Manufacture of paper and paper products industry total revenue make up 0.47% to the country's GDP in 2016, compared to 0.45% for 2015 and 0.42% in 2014.


INDUSTRY'S NET SALES REVENUE STRUCTURE BY SECTORS



We expect, based on the trend in the last three years, the total revenue of the Manufacture of paper and paper products industry to change at a compound annual growth rate (CAGR) of 12.91% in 2017.

# **IV. EXPENSES**

The combined costs of the companies in the Manufacture of paper and paper products industry reached RON 4,099,165,504 in 2016.

In annual terms, total expenses rose by 11.93% compared to 2015 and grew by 27.15% in comparison to 2014.



Manufacture of wallpaper marked the highest annual rise in total expenses, of 22.92%.

Others

The biggest spenders in the industry, with costs of over 10% of industry's costs, numbered 25, including DS SMITH PACKAGING ROMANIA SRL, PIGNA ROMANIA IMPEX SRL, MAYR MELNHOF PACKAGING ROMANIA SRL, GPV ROMANIA PRODCOM SERV SRL, TIGER SOMES IMPEX SA. The medium spenders, or those in the 5% and 10% range count 12 and include DENTAS ROMANIA SRL, INOVALABEL SRL, CHIHLIMBAR SRL, ABC-IMPEX SRL, BUDAVAL RO SRL. Below 5% threshhold are 745 companies, including GOERNER PACKAGING SRL, ECOBOX SOLUTIONS SRL, OCTAPAPER SRL, LAREM COM SRL, ESIMDAL SRL.

Employment expenses in the Manufacture of paper and paper products industry grew by 18.40% on the year to RON 459,412,310 in 2016.

The highest growth in labour costs, of 29.01%, was registered by Manufacture of household and sanitary goods and of toilet requisites, while Manufacture of wallpaper marked the sharpest fall, of 4.28%.

The monthly costs per employee in the Manufacture of paper and paper products industry averaged RON 3,008 in 2016, RON 2,742 in 2015 and RON 2,534 in 2014.



The industry's net profit amounted to RON 209,072,472 in 2016, compared to a net profit of RON 192,350,394 in 2015 and a net profit of RON 152,308,402 in 2014.







The Manufacture of paper and paper products industry's return on equity (ROE) is 10.80% compared to 10.76% in 2015 and 9.50% in 2014.

The Manufacture of paper and paper products's return on assets (ROA) was 4.92%, while in 2015 it amounted to 4.85% and 4.48% in 2014.

About 20.00% of the 10 leading companies in terms of net profit per employee are located in Timis, while 10.00% are Cluj-based and 10.00% are headquartered in Ilfov.

The average net sales revenue per employee in the Manufacture of paper and paper products industry amounted to RON 328,438 in 2016, up by 3.91% compared to 2015 and up by 10.97% compared to 2014.

The Manufacture of paper and paper products industry generated an average RON 341,295 in total revenue per employee. In 2015 and 2014 the figure was RON 329,700 and RON 310,984, respectively.

The average total revenue per company in the Manufacture of paper and paper products industry rose to RON 5,554,117 in 2016 from RON 5,082,981 in 2015. The 2014 value was RON 4,666,891.

A company in the Manufacture of paper and paper products industry made on average a net sales revenue of RON 5,344,891 in 2016, compared to RON 4,872,788 in 2015 and RON 4,441,581 in 2014.

The Manufacture of paper and paper products industry made 0.35% of the overall sales country-wide, rising its market share by 0.03 pp.



A total of 12,726 people were employed in the Manufacture of paper and paper products market at the end of 2016, compared to 11,794 in 2015 and 10,955 in 2014.


